ORDINANCE(S)

5414-2017 AN ORDINANCE ESTABLISHING THE OVI TASK FORCE GRANT FUND AND DECLARING AN EMERGENCY.

WHEREAS, the City of North Ridgeville has been awarded a grant by the Ohio Department of Public Safety for OVI enforcement and education; and

WHEREAS, in accordance with the Ohio Revised Code §5705.09(F), the City must establish a fund to account for the grant proceeds and related program expenditures.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. That there is hereby established the “*OVI Task Force Grant Fund*” to be used to account for the grant proceeds and related program expenditures.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure, the emergency being the need to meet the deadline since the City is taking the lead as the fiscal agent. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

**5415-2017 AN ORDINANCE AMENDING TEMPORARY APPROPRIATION
ORDINANCE NO. 5411-2016 OF THE CITY OF NORTH RIDGEVILLE, OHIO
FOR THE PERIOD COMMENCING JANUARY 1, 2017 AND ENDING MARCH
31, 2017 AND DECLARING AN EMERGENCY.**

WHEREAS, it is necessary to appropriate certain unanticipated funds and amend other previously appropriated amounts for the operations of the City of North Ridgeville, Ohio.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH
RIDGEVILLE, LORAIN COUNTY, OHIO:**

SECTION 1. That to provide for current and other expenditures for the City of North Ridgeville, Ohio for the period commencing January 1, 2017 and ending March 31, 2017, Ordinance No. 5411-2016 be and the same is hereby amended in the following amounts so that from and after the effective date of the Ordinance, the appropriation Ordinance shall include the following, being adjusted for the similar terms in the preceding appropriation Ordinance.

SECTION 2. That there be appropriated from the respective funds listed below, the total sums as follows:

SECTION 3. That the Auditor of the City of North Ridgeville is hereby authorized to draw warrants on the Treasury of the City of North Ridgeville for payments on any of the foregoing appropriations, upon receiving proper certification and vouchers therefore, approved by officers authorized by law to approve the same or by an Ordinance or Resolution of Council to make the expenditure and provide that no warrants may be drawn or paid for salaries or wages, except to persons employed by authority of or in accordance with law or Ordinance.

SECTION 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements.

SECTION 5. This Ordinance is hereby declared to be an emergency measure, the emergency being the need to have the Ordinance in place since these are for the period commencing January 1st. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

5416-2017 AN ORDINANCE AMENDING N.R.C.O. SECTION 624.141 MARIJUANA DRUG PARAPHERNALIA IN ORDER TO CONFORM WITH THE OHIO REVISED CODE.

WHEREAS, City Council and the Administration desire to bring the North Ridgeville Codified Ordinances into conformity and agreement with the Ohio Revised Code regarding driver's license suspensions related to marijuana and marijuana paraphernalia offenses; and

WHEREAS, subsection (g) of N.R.C.O. Section 624.141 *Marijuana Drug Paraphernalia* currently states:

(g) In addition to any other sanction imposed upon an offender for a violation of this section, the court shall suspend for not less than six months or more than five years the offender's driver's or commercial driver's license or permit. If the offender is a professionally licensed person, in addition to any other sanction imposed for a violation of this section, the court immediately shall comply with Ohio R.C. 2925.38. (ORC 2925.141).

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. Subsection (g) of N.R.C.O. Section 624.141 *Marijuana Drug Paraphernalia* is hereby amended to read as follows:

(g) In addition to any other sanction imposed upon an offender for a violation of this section, the court may suspend for not more than five years the offender's driver's or commercial driver's license or permit. If the offender is a professionally licensed person, in addition to any other sanction imposed for a violation of this section, the court immediately shall comply with Ohio R.C. 2925.38. (ORC 2925.141).

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

5418-2017 AN ORDINANCE AMENDING N.R.C.O. SECTION 624.03 DRUG ABUSE; CONTROLLED SUBSTANCE POSSESSION OR USE IN ORDER TO CONFORM WITH THE OHIO REVISED CODE.

WHEREAS, City Council and the Administration desire to bring the North Ridgeville Codified Ordinances into conformity and agreement with the Ohio Revised Code regarding driver's license suspensions related to marijuana and marijuana paraphernalia offenses; and

WHEREAS, subsection (d) of N.R.C.O. Section 624.03 *Drug Abuse; Controlled Substance Possession or Use* currently states:

(d) In addition to any other sanction that is imposed for an offense under this section, the court that sentences an offender who is convicted of or pleads guilty to a violation of this section may suspend for not less than six months or more than five years the offender’s driver’s or commercial driver’s license or permit.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. Subsection (d) of N.R.C.O. Section 624.03 *Drug Abuse; Controlled Substance Possession or Use* is hereby amended to read as follows:

(d) In addition to any other sanction that is imposed for an offense under this section, the court that sentences an offender who is convicted of or pleads guilty to a violation of this section may suspend the offender’s driver’s or commercial driver’s license or permit for not more than five years.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
