## ORDINANCE(S)

(The following Ordinance(s) were adopted by City Council on January 19, 2016)

**5312-2016 AN ORDINANCE AMENDING TEMPORARY APPROPRIATION ORDINANCE NO. 5302-2015 FOR THE CITY OF NORTH RIDGEVILLE, OHIO FOR THE PERIOD COMMENCING JANUARY 1, 2016 AND ENDING MARCH 31, 2016 AND DECLARING AN EMERGENCY.**

**WHEREAS**, it is necessary to appropriate certain unanticipated funds and amend other previously appropriated amounts for the operating of the City of North Ridgeville, Ohio.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:**

**SECTION 1.** To provide for current and other expenditures for the City of North Ridgeville, Ohio for the period commencing January 1, 2016 and ending March 31, 2016, Ordinance No. 5302-2015 be and the same are hereby amended in the following particulars so that from and after the effective date of the Ordinance, the temporary appropriation Ordinance shall include the following, being adjusted for the similar terms in the preceding temporary appropriation Ordinance.

**SECTION 2.** That there be appropriated from the respective funds listed below, the additional sums as follows:

**SECTION 3.** That the Auditor of the City of North Ridgeville be and he is hereby authorized to draw warrants on the Treasury of the City of North Ridgeville for payments on any of the foregoing appropriations, upon receiving proper certification and vouchers therefore, approved by officers authorized by law to approve the same or by an Ordinance or Resolution of Council to make the expenditure and provide that no warrants may be drawn or paid for salaries or wages, except to persons employed by authority of or in accordance with law or Ordinance.

**SECTION 4.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 5.** This Ordinance is hereby declared to be an emergency measure, the emergency being the immediate necessity to meet the deadline. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

**5313-2016 AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT(S) WITH CDW FOR PROFESSIONAL INFORMATION TECHNOLOGY SERVICES FOR IMPROVEMENTS TO THE CITY'S COMPUTER SYSTEM, SWITCH UPGRADES, VIRTUALIZATION OF CITY SERVERS, VIRTUALIZATION OF PC DESKTOPS AND APPURTENANCES, NOT TO EXCEED A TOTAL CUMULATIVE AMOUNT OF \$105,000.00 AND DECLARING AN EMERGENCY.**

**WHEREAS,** it is in the best interest of the City and the demands of the resident population to improve the functionality of the City's computer system; and

**WHEREAS,** virtualization of City servers will provide the City with the ability to configure new servers more quickly and easily and provide a foundation for better disaster recovery, and virtualization of City employee PC desktops will help extend the life of existing PC hardware and provide better support and recovery from issues such as viruses and desktop corruption, and provide better access to certain applications that have limited licensing; and

**WHEREAS**, hardware, software and any appurtenances shall be provided/purchased from the State Co-Op or from outside vendor(s) at an equivalent or lesser price.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** The Mayor is hereby authorized to enter into a contract(s) with CDW for professional information technology services for improvements to the City’s computer system, switch upgrades, virtualization of City servers, virtualization of PC desktops and appurtenances, not to exceed a total cumulative amount of \$105,000.00.

**SECTION 2.** The cost of these projects shall be charged to the appropriate fund(s).

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, the emergency being the need to spend the funds appropriated in 2015 that were carried over for 2016 and to get the project underway. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
