### ORDINANCE(S)

**5412-2017 AN ORDINANCE AMENDING ORDINANCE NO. 5392-2016 BY INCREASING THE AMOUNT TO BE EXPENDED FOR CONSULTING ENGINEERING COSTS FOR THE JAYCOX ROAD EXTENSION PROJECT FROM \$189,000.00 TO NOT TO EXCEED \$250,000.00 AND DECLARING AN EMERGENCY.**

**WHEREAS**, Ordinance No. 5392-2016 amended Ordinance No. 5255-2015, which permitted the City to enter into a contract with a consulting engineering firm for the Jaycox Road extension design; and

**WHEREAS**, the widening of Jaycox Road requires additional wetlands permitting services and the revision of plans, increasing the cost of this project.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** Ordinance No. 5392-2016 is hereby amended by increasing the amount to be expended for consulting engineering costs from \$189,000.00 to not to exceed \$250,000.00.

**SECTION 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, the emergency being for the health, safety and welfare of the citizens in order to get the road constructed before school begins next year. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

**5413-2017 AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE, OHIO TO ENTER INTO A CONTRACT WITH THE AMERICAN FEDERATION OF STATE, COUNTY AND MUNICIPAL EMPLOYEES, AFL-CIO AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Council and Administration of the City of North Ridgeville, Ohio, have conducted extensive negotiations with the Ohio Council 8 and Local 3442 of the American Federation of State, County and Municipal Employees, AFL-CIO as the bargaining representative for its members and such negotiations have resulted in a tentative agreement between the parties.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** The Mayor is hereby authorized and directed to enter into an agreement with the American Federation of State, County and Municipal Employees, AFL-CIO, upon the terms and conditions as substantially (allowing for possible non-substantive grammatical corrections or format adjustments) set forth in **Exhibit "A"** attached hereto and made a part hereof as though fully rewritten herein, on behalf of all of the employees in the bargaining unit.

**SECTION 2.** Said contract shall be effective January 1, 2017 through December 31, 2019, and shall be deemed retroactively effective to that date of commencement as to all terms therein, including wages, as if this ratifying Ordinance was adopted prior to January 1, 2017.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, the emergency being due to the contract being retroactive. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
