ORDINANCE(S)

5567-2018 AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE TO ENTER INTO A FAIR MARKET VALUE LEASE AGREEMENT WITH R & K TECHNOLOGIES, INC. FOR MULTI-FUNCTION PRINTERS AND DECLARING AN EMERGENCY.

WHEREAS, the City's current lease agreement for multi-function printers will be expiring this year; and

WHEREAS, the City has issued a request for proposals to multiple vendors which detailed the required specifications and mandated that all equipment appearing in any proposal submitted appear on the current State bid list; and

WHEREAS, the proposal submitted by R & K Technologies, Inc. has been determined to best serve the City by the Administration.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The Mayor is hereby authorized to enter into a Fair Market Value Lease Agreement with R & K Technologies, Inc. in a form substantially similar to the attached **Exhibit "A"**.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure, the emergency being the immediate need to have the current contract in place so there is not a lapse in service and provide ample time for equipment to be ordered and installed. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

5568-2018 AN ORDINANCE TO APPROVE THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AND RESOLUTIONS AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES; TO APPROVE, ADOPT, ENACT AND PUBLISH NEW MATTER IN THE UPDATED AND REVISED CODIFIED ORDINANCES; AND TO REPEAL ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH.

WHEREAS, the Walter H. Drane Company has completed the 2018 updating and revision of the codified Ordinances of the City; and

WHEREAS, various Ordinances and Resolutions of a general and permanent nature that have been passed by Council since the date of publication of the codified Ordinances (December 31, 2005) have been included in the codified Ordinances of the City; and

WHEREAS, certain changes were made in the codified Ordinances to bring City law into conformity with State law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The editing, arrangement and numbering or renumbering of the following Ordinances and Resolutions and parts of Ordinances and Resolutions are hereby approved as parts of the various component codes of the codified Ordinances of the City, so as to conform to the classification and numbering system of the codified Ordinances.

SECTION 3. All Ordinances and Resolutions and parts thereof that are in conflict with any of the provisions of the new matter approved, adopted and enacted by Section 2 hereof are hereby repealed, except as follows:

(a) The enactment of such new matter shall not be construed to affect a right or liability accrued or incurred under any legislative provision prior to the effective date of such enactment, or an action or proceeding for the enforcement of such right or liability. Such enactment shall not be construed to relieve any person from punishment for an act committed in violation of any such legislative provision or to affect an indictment or prosecution therefor. For such purposes, any such legislative provision shall continue in full force notwithstanding its repeal for the purposes of revision and recodification.

(b) The repeal provided above shall not affect any legislation enacted subsequent to October 6, 2008.

SECTION 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 5. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
