LEGAL NOTICE

Sealed proposals will be received at the Office of the Mayor, City Hall, 7307 Avon Belden Road, North Ridgeville, Ohio 44039 until 11:00 A.M. (Local Time) on May 8, 2017 and will be opened and read immediately thereafter for:

MILLS ROAD AND S.R. 83 ROUNDABOUT PROJECT

The work will consist of removing the existing traffic signal and reconstruction of the intersection with a single lane roundabout including new full depth asphalt pavement and curb and gutter as well as drainage improvements, signing and striping, intersection lighting, and other related work. The roundabout inscribed diameter will be 135 feet with 12' travel lanes at the approaches and 18' along the circulatory path, and other related work.

Bidders will be required to use the printed bid forms, which will be available along with the bid specifications from the Office of the Engineer, City Hall 7307 Avon Belden Road, North Ridgeville, Ohio 44039. Checks shall be made payable to the City of North Ridgeville, Ohio, at a non-refundable cost of sixty-five dollars (\$65.00) picked up. No plans will be mailed.

Each proposal shall be accompanied by a bid guarantee which shall consist of an Ohio Statutory Bid Guaranty and Contract Bond, substantially in the form prescribed by ORC 153.57 in a penal amount equal to or greater than 100% of the bid price. No other form of bond is acceptable. Bid security furnished in bond form shall be issued by a surety Company or Corporation licensed in the State of Ohio to provide said surety.

The City of North Ridgeville, Ohio reserves the right to reject any or all Bids and to waive any irregularities in bidding.

Each proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity.

Sealed bids must be marked on the front of the envelope: "Mills Road and S.R. 83 Roundabout"

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the Equal Employment Opportunity requirements of Ohio Administrative Code, Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9, shall be required.

Domestic steel use requirements as specified in Section 153.011 of the Revised Code apply to this project. Copies of Section 153.011 of the Revised Code can be obtained from any of the offices of the Department of Administrative Services.

Bidders must comply with the prevailing wage rates on Public Improvements in Lorain County and the City of North Ridgeville, Ohio, as determined by the Department of Commerce, Division of Labor and Worker Safety, Bureau of Wage and Hour.
