NORTH RIDGEVILLE CITY COUNCIL MEETING MINUTES JANUARY 17, 2017

CALL TO ORDER: 7:30 P.M.

President Corcoran: Calling to order the Tuesday, January 17, 2017 regular Council meeting.

INVOCATION:

Led by President Corcoran.

PLEDGE OF ALLEGIANCE:

ROLL CALL:

MINUTES - Corrections (if any) and approval:

President Corcoran: You have before you the City Council minutes of January 3, 2017. Are there any objections or corrections to approving those minutes? Seeing none, those minutes are approved.

President Corcoran: Please note we received the Board of Drainage and Flood Control minutes of October 25, 2016 and the Planning Commission minutes of January 10, 2017.

LOBBY:

President Corcoran: We are only going to have one lobby session this evening. We are opening up lobby session right now. If you would like to speak, please step up to the podium. You will be given three minutes to speak. Would anybody like to speak?

President Corcoran: Moving on then to the Administrator's reports. Mr. Mayor, you are up first.

ADMINISTRATORS REPORTS:

A. Mayor: Thank you Mr. President. First, I would like to recommend that City Council appoint James Maleski to Planning Commission. Mr. Maleski is currently employed at Huron City Schools as a World History Teacher. With his work experience, coupled with his leadership skills, I think he will be a great asset to Planning Commission.

Mr. Maleski will be filling the vacancy left by the recent resignation of Jim Rothgery at the end of his term. Jim had served for 13 years and had spent countless hours doing his due diligence in

researching his recommendations before bringing them to the Commission at large. I want to thank him for his service and wish him well in all future endeavors.

Moved by Mayor Gillock and seconded by Johnson to approve the appointment of Jim Maleski to the four year term as a member of the Planning Commission.

President Corcoran: Are there any comments or questions? All those in favor say yes. Those opposed say no.

President Corcoran: Thank you, Mr. Mayor. Mr. Safety-Service Director.

B. Safety-Service Director: Our ditch cleaning is continuing with our two track hoes that we have out there. Unfortunately, it doesn't help us much when it is raining to fill the chuck holes that have started to appear again, especially up at LCCC and Lorain Road and in other places. When it is wet like this, we really can't go out and use the equipment we've got because you can't get a seal in the hole, it is too wet, and it will just pop right back out. So, we will be

back out tomorrow if it doesn't rain tonight and use the two pieces of equipment we've got that are working well.

I'm not sure if any of you drive any of the City vehicles, but you might be receiving an email requesting us to validate your driver's license. We do this on an annual basis, making sure that all of our employees have valid driver's license for insurance purposes. So, if you do hear some mumbling and you do get an email and you don't use it, don't worry about it, but I'm sure that everybody up here has a valid driver's license. Every once in a while, somebody doesn't remember it is their birthday and so, maybe this will give you a wakeup call to look at your own driver's license to figure out whether yours is valid or not and those of you that are watching out in TV land, you might want to look at yours too because a valid driver's license is pretty important, especially to the City employees that drive our vehicles. Thanks and that concludes my report.

President Corcoran: Thank you. Mr. Engineer.

C. Engineer: Thank you, Mr. President. I'm happy to report that yesterday the contractor took advantage of the small window that met our guidelines for applying the stripping on Lear. The strips that had faded away are now visible again. I also had fielded a few questions on the mailboxes on Lear. The grading work is not complete and won't be complete until the spring. The mailbox situation where they are all located in a single place will continue until that grading work is done. We are working with the post office to see if we can get packages delivered to the houses.

Lastly, I have reached out to two separate consultants to give me a proposal to do a study of our water system to update our water model to forecast our future water needs and to give us feedback as to potential locations for a second water tower to continue to serve our growing City's water needs. That concludes my report.

President Corcoran: Thank you, Mr. Auditor.

D. Auditor: Thank you Mr. President. I have several items tonight. Last Friday, the preliminary year-end financial report was sent to everybody. That is just a preliminary report. Our actual annual report is in the process of being completed. It should be somewhere around May that it is done and audited. Our annual audit will start February 21st this year. The Auditor of State won't be preforming the audit, Zupka and Associates will be.

Last week, Council was informed about water rate increase of 5.32%. Annually, we look at the cost of water that we paid in the prior calendar year and that drives the increase for the current year. That is under Ordinance 2665-1992. We've experienced an increase from our suppliers. The two biggest suppliers are Avon Lake and Elyria. Avon Lake had the largest increase. Again, there will be a 5.32% water increase. I put before you a summary of the calculations or the cost of the water that we buy from our four suppliers for you to look at. The actual cost last year is what drives a rate increase for this year.

There are two pieces of legislation that were sent to you last week. One was a supplemental appropriations and the other one approval for an OVI Grant Fund. Recently, the Police Department was awarded an OVI Grant and we are the fiscal agent for the grant. The Police Department is the lead agency for Lorain County on it. This came up quickly so that is why you have the legislation in front of you. I ask that both pieces be approved with the emergency clause tonight - the emergency being the immediate need to receipt the grant proceeds and pay obligations that are in existence under this grant. Are there any questions? Otherwise, that concludes my report.

President Corcoran: Thank you.
