President Corcoran: Seeing none, moving on then to the Administrator's reports. Mr. Safety-Service Director, you are up first.

# **ADMINISTRATORS REPORTS:**

A. Mayor: Absent.

**B.** Safety-Service Director: Mayor Gillock is unable to attend tonight. He is in Columbus at the Ohio Energy Conference, but he had several items that he would like me to report on. Wow Cable along with the subcontractors are working throughout the City to install their network through existing utility easements such as gas, electric, water and sewer lines and through the right-of-way, the road right-of-way. We have taken a number of residential calls, including some of you here, asking about why there are flags on the property or why there are

shovels or why people are walking on the property. It is Wow. They are doing their best to place ... to look at the easements that are out there. The flags are marking various utilities so that Wow can install their infrastructure and bring the services to our residents. This will provide residents an alternative from Spectrum, formerly Time Warner, and give you the option between Time Warner and Wow.

The next coffee and conversation with Mayor Gillock will take this place this Friday, February 24 at 8:00 a.m. at Kim's Restaurant.

The Regional Income Tax Agency will have agents on site, meaning here at City Hall in this Council Chambers to answer questions and assist with R.I.T.A. municipal income tax return preparation on Tuesday, March 7, between 1:00 p.m. – 7:00 p.m. on a first come, first-served basis. If you want to come, you can have someone from R.I.T.A. help you and answer questions and help you do your taxes. Visit the City website at nridgeville.org to obtain a list of items that you will need to bring with you in order to have the agents assist you in preparing your taxes.

Most recently, this past Thursday and Monday, Park and Rec had a very successful outdoor pool discussion. There were twenty-five attendees Thursday night and a little over sixty last night. It was very well attended. There were a lot of good questions both Thursday and last night's meeting there was a lot of good questions asked. We look forward to the development of that plan and I'm sure Kevin would like to see a pool. I'm not sure there is going to be one, but certainly getting input from the residents of the City of North Ridgeville.

Here it is February 21<sup>st</sup>, the windows are open. I've never seen that in my entire life and I have been around for a long time. To have 70 degree weather over the weekend and see what we are going to maintain in the next few days – this is unbelievable the weather that we are having. Those people that went south during this week are certainly wondering if they should have waited. It will probably be really cold and a lot of snow at the end of February.

President Corcoran: Thank you.

Councilwoman Butkowski: I wanted to add to what Mr. Armbruster said – we are eight and a half inches below normal on snow. We save on a lot of salt that way.

Councilman Boose: Mr. President, just a question or a comment – I am assuming those that want to come for the R.I.T.A. taxes – that is just for City tax that they will do, correct? They aren't going to do your federal tax.

Safety-Service Director Armbruster: No – just City taxes.

Councilman Boose: Just wanted to make sure we get that. Don't want people coming here thinking they will get their federal or state tax done.

**C. Engineer:** Thank you, Mr. President. I mentioned earlier about the failing striping on Lear that was causing some stress for the drivers and took advantage of this unseasonably warm weather. The few days of warm we had over the weekend gave the pavement time to heat up to the point when we painted it Monday, we had almost ideal conditions for the temporary painting so that is completed and those strips are nice and bright. Hopefully, it should last longer even though it is temporary paint. That concludes my report.
