<u>Mike Babet, 38601 Sugar Ridge Road:</u> asked the Engineer when the calculations are done, does the City look at the infiltration of water into the ditches. He further added if the previous phases are looked at.

Engineer Rodriguez stated yes they look at the calculations from the previous phases.

Mr. Babet asked if the ditch west of Waterbury is planned to be cleaned.
