COUNCIL LIAISONS REPORT:

Councilman Dennis Boose reported that construction season already started. Widening of Center Ridge has begun and they will be building a temporary lane to control traffic. Councilman Boose mentioned the family outdoor aquatic center and feels that the pool should be put on the ballot this year.

SCHOOL BOARD LIAISONS REPORT:

No report.

FINANCIAL REPORT:

Parks and Recreation Director Kevin Fougerousse discussed the revenues and expenses. Trust Fund revenue through February 2018 was \$22,764.37. Trust Fund statement of cash through February 2018 is \$182,042.02. The Park and Recreation Improvement Fund revenue through February was \$4,938.80. The Park and Recreation Improvement Fund statement of cash through February 2018 is \$163,417.44. Trust Fund expenses in February were \$7,875.58 and our General Fund expenses in February were \$24,081.81.

DIRECTORS REPORT:

Parks & Recreation Director Kevin Fougerousse mentioned that this meeting is Frank Vacha's last he is transitioning to the Service Garage to work in the capacity of a Laborer. We hired Paul Rockocy as our new Program Supervisor. We had 115 applicants, narrowed it down to 09 for 1st round interviews and brought back the top 3 the week of March 5. Paul received a Bachelor of Arts degree with a Sport Management degree in 2016 and he is finishing his MBA this summer.

We are submitting our grant application to the state on or before June 1. County allocation is \$104, 277.00. The application will be to finish our ³/₄ mile trail at Shady Drive and add 07 pieces of outdoor fitness equipment to the trail.

PROGRAM SUPERVISOR REPORT:

Big Magic with the Magic Man started on March 3 and we had a total of 6 pre-registered. Rumble, Tumble & Roll started on March 5 with 10 little ones pre-registered. Tumble Bugs started also on March 5 with 10 pre-registered. Both those programs were full. Senior Fit started on March 8 with 04 pre-registered. Hoop Stars & Little Hoop Stars is ran by Jump Start Sports and started on April 3. Our youth baseball / softball program has 42 teams currently 512 kids pre-registered. Equipment pick-up is on April 7 from 8:00a.m.-10:00a.m. and pant pick-up is April 7 & 14 from 8:00a.m.-10:00a.m. We also received a \$500 grant from ODNR step outside grant to be used toward our fishing derby.

GROUNDS MAINTENANCE REPORT:

John Schneider, Assistant Grounds Maintenance Supervisor reported that they renovated the office; it was in dire need of an upgrade. Getting all our mowers & weed whips ready for the season. We hired 02 seasonal employeess for 12 weeks; anticipated started date is May 14. Our service garage started work on the parking lot at Shady Drive. The parking lot will be paved this fall.

OLD BUSINESS:

Councilman Boose brought up that he once again would like to see the outdoor family aquatic center on the ballot this November.
