# **REPORTS:**

## **COUNCIL LIAISONS REPORT:**

Councilman Bruce Abens reported that City Council is still working on compensation for City Engineer & Parks & Recreation Director. Rezoning of Bender & Sugar Ridge is in front of council at this time. They would like to re-zone as commercial/light industrial.

#### SCHOOL BOARD LIAISONS REPORT:

Kelly McCarthy reported they are in the final stages of the North Ridgeville Academic Center. First day of school is Wednesday, September 6.

## FINANCIAL REPORT:

Parks and Recreation Director Kevin Fougerousse discussed the revenues and expenses. Trust Fund revenue through July 2017 was \$20,973.48. Trust Fund statement of cash through July 2017 is \$212,554.07. The Park and Recreation Improvement Fund revenue through July was \$34,406.33. The Park and Recreation Improvement Fund statement of cash through July 2017 is \$221,217.29. Trust Fund expenses through July are \$121,694.10 and our General Fund expenses are \$146,797.37.

#### **DIRECTORS REPORT:**

Parks & Recreation Director Kevin Fougerousse discussed that the South Central Park – Tennis Court Project was re-bid and was awarded to Chagrin Valley Paving, Inc. They were the only bidder. Their bid came in at \$121,038.50. Chagrin Valley Paving was within the 10% to award and construction on the courts is anticipated to start in September.

## PROGRAM SUPERVISOR REPORT:

Over the summer we held a Bricks 4 Kidz Super Hero Program, we had 05 that pre-registered. Summer Adventure Camp concluded on July 28. We had a total of 156 kids register, an increase of 37 kids from 2016. Junior Ranger Cheer Program is full with 20 kids; it is open to boys/girls in grades K-6. Jump Start Sports Flag Football is being held starting on September 11. Jump Start Sports T-Birds / T-Ball Program starts on September 8 for ages 3-4. Jump Start Sports Rookie League runs on September 8 and is for ages 5-6.

## **GROUNDS MAINTENANCE REPORT:**

Parks and Recreation Director Fougerousse reported on behalf of Grounds Maintenance Supervisor Gary Teel. Grounds division installed new trash cans around the walking trail in South Central Park.
