#### ORDINANCES AND RESOLUTIONS

(The following Ordinances and Resolutions were passed by City Council on August 4, 2014)

### 1312-2014 A RESOLUTION OF SUPPORT FOR OHIO PUBLIC WORKS COMMISSION PRIORITIES, AND DECLARING AN EMERGENCY.

**WHEREAS,** Scott Wangler, the City Engineer, has submitted to Council an Infrastructure List and cost estimates for the 2014-2015 projects within the City of North Ridgeville, Ohio, which are or may be eligible for Ohio Public Works Commission funding; and

**WHEREAS**, the Administration and Council of the City of North Ridgeville wish to express to the Ohio Public Works Commission their recognition and support of the importance and priority of these projects.

## NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** Council does hereby give its support for the grant request priority list for Ohio Public Works Commission funding submitted to the Council by the City Engineer for Ohio Public Works Commission Project Funding, Round No. 29, 2014-2015, a copy of this priority list is attached hereto and marked Exhibit A.

**SECTION 2**. The Clerk of Council is hereby authorized and directed to submit a copy of this Resolution to the Ohio Public Works Commission via the City Engineer.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** That this Ordinance is hereby declared to be an emergency measure, the emergency being the immediate necessity to meet the filing deadline of September 5, 2014. WHEREFORE, this

Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

# AN ORDINANCE AMENDING N.R.C.O. 1042 FRENCH CREEK SEWER DISTRICT REGULATIONS AND ESTABLISHING UPDATED FEES AND PROVISIONS FOR OUTSIDE WASTE AND SEPTAGE WASTE HAULERS TO THE FRENCH CREEK WASTEWATER DISTRICT.

**WHEREAS**, due to increased costs of treating wastewater and maintaining a wastewater treatment system, it has been necessary to increase fees for processing outside septage; and

**WHEREAS,** in order to better serve the Facility Planning Area assigned to the FCWWTP via the Federal Clean Water Act and NOACA, and to meet the needs and serve the general welfare of the County, FCWWTP will no longer accept septage from outside of Lorain County.

#### NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** N.R.C.O. § 1042.13 (a)(3)(B) shall be amended for hauled waste of daily flows more than 6,000 but less than 12,000 GPD from \$600.00 to \$800.00; and

**SECTION 2.** N.R.C.O. § 1042.13 (a)(3)(C) shall be amended for hauled waste of daily flows more than 12,000 but less than 20,000 GPD from \$800.00 to \$1,600.00; and

**SECTION 3**. N.R.C.O. § 1042.13 (c)(1) shall be amended to state: "The City shall accept septage waste generated from residential use within the boundaries of Lorain County only, and shall charge waste haulers as follows":

**SECTION 4**. N.R.C.O. § 1042.13 (c)(1)(A) shall be amended to increase the fees for residential septage waste from \$65.00 to \$260.00 per load of 2,600 gallons or less; and

**SECTION 5**. N.R.C.O. § 1042.13 (c)(1)(B) shall be amended to state: A fee of \$0.09 per gallon for tankers over 2,600 gallons or total volume of the tanker containing loads from outside the French Creek FPA, and a fee of and \$0.07 per gallon for loads generated from inside the French Creek FPA; and

**SECTION 6.** N.R.C.O. § 1042.13(c)(1)(C) shall be amended to state: "The Superintendent is authorized to assess surcharges for excessive solids present in the septage waste and for septage loads from residential sites;" and

**SECTION 7.** N.R.C.O. § 1042.13(c)(1)(D) shall be amended to state: "The Superintendent is authorized to charge for analyzing samples of septage waste from residential waste to determine compliance with hazardous waste rules and local limits for metals;" and

**SECTION 8.** N.R.C.O. § 1042.13(c)(1)(E) shall be amended to state: "The Superintendent is authorized to increase the fees collected by ten (10%) percent effective January 1, 2015."

**SECTION 9.** N.R.C.O. § 1042.13 (c)(2) shall be amended to state: "Septage waste haulers transporting waste other than residential septage waste shall be required to apply and obtain an individual discharge permit from the French Creek Wastewater Treatment Plant."

**SECTION 10.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 11.** This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

AN ORDINANCE AMENDING ARTICLE 26 WAGE RATES OF ORDINANCE NO. 4916-2012, AND AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE TO ENTER INTO AN AGREEMENT WITH CERTAIN MEMBERS OF THE FRATERNAL ORDER OF POLICE, OHIO LABOR COUNCIL, INC., AND DECLARING AN EMERGENCY.

**WHEREAS,** on April 16, 2012, City Council passed Ordinance No. 4916-2012, entering into a 3-year contract with the Fraternal Order Of Police, Ohio Labor Council, Inc., North Ridgeville Division, which commenced January 1, 2012, and shall end on December 31, 2014;

**AND WHEREAS,** Article 37.02 of said FOP contract states: "There shall be a wage re-opener effective November 1, 2013 for the purpose of negotiating wage rates during the 2014 calendar year."

**AND WHEREAS,** the City and the FOP union have conducted negotiations, resulting in fact finding;

**AND WHEREAS,** only the members of the white unit (dispatchers) of the union have voted to accept the fact finder's report, accepting a 2% wage increase for 2014.

## NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** The Mayor is hereby authorized to enter into an agreement with certain members (white unit) of the Fraternal Order of Police, Ohio Labor Council, Inc., North Ridgeville Division, by increasing wage rates by 2% for the year 2014.

**SECTION 2.** Ordinance No. 4916-2012 is hereby amended by establishing 2014 wage rates for the following positions contained in Article 26 of the FOP Agreement:

**SECTION 3.** Said wage increase shall be effective January 1, 2014, and shall continue until a new contract has been negotiated.

**SECTION 4.** In all other respects, Ordinance No. 4916-2012 shall remain in full force and effect as previously passed and approved.

**SECTION 5.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 6.** This Ordinance is hereby declared to be an emergency measure, the emergency being to improve our position in future negotiations and the immediate necessity of providing for the health, safety and welfare of the community. WHEREFORE, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

# 5160-2014 AN ORDINANCE APPROVING THE SALE OF CERTAIN PERSONAL PROPERTY OWNED BY THE CITY OF NORTH RIDGEVILLE PURSUANT TO O.R.C. SECTION 721.15(D).

**WHEREAS**, the City of North Ridgeville, pursuant to O.R.C. Section 721.15(D), may sell certain personal property in a manner authorized by law; and

**WHEREAS,** North Ridgeville City Ordinance No. 4177-2005 and amending Ordinance No. 4711-09 permit the sale of City-owned personal property via Internet auction; and

**WHEREAS**, the following City-owned equipment is not being used by the City and no longer serves a municipal purpose: Yokagawa meters, stainless steel storage tanks, white plastic storage tank, oil separator, staging tank, conditioning tank, chain hoist crank, Leeson blower, bumper power crane, A & A portable truck scales; and

**WHEREAS**, each item listed above is valued in excess of \$1,000.00, therefore the sale of this equipment must be approved by Council.

## NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** City Council finds that the above listed equipment no longer serves a municipal purpose and hereby approves the sale of these assets via Internet auction.

**SECTION 2.** Proceeds from the sale of the above listed items shall be deposited into the appropriate City fund(s).

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
