## **RESOLUTION NO. 1232 - 2011**

A RESOLUTION PURSUANT TO NRCO 214.01, PROCEDURES FOR SALES BY INTERNET AUCTION, EXPRESSING LEGISLATIVE INTENT TO SELL CERTAIN PROPERTY BY INTERNET AUCTION AND DECLARING AN EMERGENCY.

**WHEREAS**, the North Ridgeville City Council has adopted certain procedures for sale of items by internet auction and pursuant to ORC 721.15 intends to sell those items during the ensuing calendar year.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** The North Ridgeville City Council finds that certain City property, including but not limited to, motor vehicles, road machinery, equipment, tools, supplies, computer hardware, software, accessories, or any other municipal property acquired or owned by the City and which are not needed for public use and/or is obsolete or unfit for the use for which it was acquired, shall be sold by internet auction in the manner prescribed by law.

**SECTION 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Resolution is hereby declared to be an emergency measure, the emergency being the immediate necessity to provide for the health, safety and welfare of the Citizens of the City of North Ridgeville, Ohio by expressing legislative intent to sell certain property by internet auction and for the further reason of the necessity to sell the police cars currently listed on GovDeals.com; WHEREFORE, this Resolution shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
