RESOLUTION NO. 1522-2021

WHEREAS, the City's Fiscal Officer certifies that the expenditure was and is properly appropriated and otherwise lawful; sufficient funds were and are available or in the process of collection to the credit of the proper fund, and the funds were and are free from any previous encumbrance; and

WHEREAS, the City is issuing Then and Now Certificates in connection with payments due and owing as shown in Exhibit A attached; and

WHEREAS, City Council deems it to be in the best interest of the health, safety and welfare of the City to approve the execution by the City Fiscal Officer of Then and Now Certificates, and to authorize the payment of amounts due under the contracts or orders requiring the expenditure of \$3,000.00 or more.

AN ORDINANCE AMENDING ORDINANCE 5788-2021 TO PURCHASE GALAXY AND ULTRASONIC WATER METERS AND APPURTENANCES FROM BADGER METER, INC., BY AMENDING THE NOT TO EXCEED COST FROM \$200,000.00 TO \$400,000 FOR CALENDAR YEAR 2021 AND DECLARING AN EMERGENCY.

WHEREAS, per Ordinance No. 4634-2009, the City entered into a contract with Badger Meter, Inc. for the installation and implementation of the AMR water meter automated system; and

WHEREAS, the City must purchase additional Galaxy and Ultrasonic water meters, which are uniquely compatible with the City's water meter system, for new construction installs and/or replacements; and

WHEREAS, Badger Meter, Inc. is the sole manufacturer of the Galaxy and Ultrasonic water meters, which are the only brand or type of meter which can be integrated into the City's existing automated system.

WHEREAS, on January 19, 2021, North Ridgeville Ordinance 5788-2021 was adopted and provided the following:

The Mayor is hereby authorized to purchase Ultrasonic water meters and appurtenances from Badger Meter, Inc., not to exceed \$200,000.00 for the year 2021.

WHEREAS, due to the anticipated new residential and commercial construction within the City and the upgrading of current meters, additional water meters are needed.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. Ordinance number 5788-2021 is hereby amended as follows:

The Mayor is hereby authorized to purchase Ultrasonic water meters and appurtenances from Badger Meter, Inc., not to exceed \$400,000.00 for the year 2021.

- **Section 2.** City Council finds that formal bidding is not required due to the fact that Badger Meter, Inc. is the sole manufacturer of the Galaxy and Ultrasonic water meters, which are unique in that they are the only product compatible with the City's existing water meter system.
- **Section 3.** The cost of the Galaxy and Ultrasonic water meters and appurtenances shall be charged to and paid from the appropriate fund.
- **Section 4.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.
- **Section 5.** This Ordinance is hereby declared to be an emergency measure, the emergency being in order to move forward with the purchase of additional water meters to meet the demand of the public. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

ORDINANCE NO. 5827-2021

AN ORDINANCE REPEALING NORTH RIDGEVILLE CODIFIED ORDINANCE SECTION 1294.09, SETBACK REQUIREMENTS FOR CENTER RIDGE ROAD, IN ITS ENTIRETY.

WHEREAS, North Ridgeville Codified Ordinance Section 1294.09 was created in 2008 to address setback requirements for the upcoming Center Ridge Road Widening Project (hereinafter the "Project") and reads as follows:

1294.09 SETBACK REQUIREMENTS FOR CENTER RIDGE ROAD.

- (a) An additional 15-foot front yard setback shall be added to all existing required front yard setbacks from the north right-of-way of Center Ridge Road/Rte. 20 from the Western municipal corporation boundary to the Eastern municipal corporation boundary.
- (b) An additional 20-foot front yard setback shall be added to all existing required front yard setbacks from the south right-of-way of Center Ridge Road/Rte. 20 from the Western municipal corporation boundary to the Eastern municipal corporation boundary. (Ord. 4501-2008. Passed 2-19-08.); and

WHEREAS, the Project was originally believed to extend along Center Ridge Road from the eastern Municipal Corporation boundary to the Western Municipal Corporation boundary; and

WHEREAS, relevant portions of the Project have been completed and the Project only extends along Center Ridge Road from Stoney Ridge Road east to Lear Nagle Road; and

WHEREAS, it is unnecessary and potentially prohibitive to future development to have portions of Center Ridge Road that were not part of the Project subjected to these additional setback requirements.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. North Ridgeville Codified Ordinance Section 1294.09, *Setback Requirements for Center Ridge Road*, is hereby repealed in its entirety.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
