WHEREAS, the City of North Ridgeville owns a parcel of approximately 12.93 acres of unimproved real property within the corporate boundaries of the City, identified as parcel no. 07-00-006-101-040 in the Lorain County Records, with an address of 5463 Mills Creek Lane, commonly known as Frontier Park; and

WHEREAS, on or about December 4, 2020, a split of 0.7329 acres of non-buildable property from said parcel was voted on and approved by the North Ridgeville Parks and Recreation Commission for subsequent sale; and

WHEREAS, the parcel and proposed split have been surveyed, appraised, and land descriptions have been completed; and

WHEREAS, the Administration now wishes to publicly advertise the property for sale in order to solicit competitive bids according to law and garner the highest and/or best sale price for this municipal asset.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. Council finds that the 0.7329-acre proposed split from the real property, identified as Parcel No. 07-00-006-101-040 in the Lorain County Records, is no longer needed for a municipal purpose.

Section 2. The Mayor is hereby authorized to advertise the 0.7329-acre proposed split for sale in a newspaper of general circulation within the municipality in accordance with the Ohio Revised Code, and then to enter into a contract of sale with the parties submitting the highest and/or best bona fide bid. All costs incurred by the City in disposing of said properties will be additional costs to be paid by the highest and/or best bidder. The Mayor shall retain the right to reject all offers in the event none are deemed sufficient.

Section 3. The sale(s) shall be consummated in such manner and on such terms as the Director of Law may approve.

Section 4. The funds generated from the sale of the properties shall be deposited to the appropriate fund(s).

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including § 121.22 of the Ohio Revised Code.

Section 6. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
