ORDINANCE NO. 5850-2021

AN ORDINANCE AMENDING ORDINANCE NO. 5802-2021 WHICH AUTHORIZED THE MAYOR TO ENTER INTO A CONTRACT WITH THE LOWEST AND BEST BIDDER FOR THE 2021 CATCH BASIN REHABILITATION PROJECT, BY INCREASING THE NOT TO EXCEED AMOUNT FROM \$50,000.00 TO \$55,000.00 AND DECLARING AN EMERGENCY.

WHEREAS, the City of North Ridgeville Service Department has identified the need to rehabilitate and/or reconstruct various catch basins throughout the City that are in need of repair; and

WHEREAS, the project was awarded to the lowest and best bidder; and

WHEREAS, the City of North Ridgeville would like to increase the not to exceed amount of Ordinance 5802-2021 from \$50,000.00 to \$55,000.00, which will cover the costs for additional concrete replacement sections around the catch basins and additional catch basin grates not originally accounted for in the scope of work at the time of bidding.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. Ordinance 5802-2021 is hereby amended by increasing the not to exceed amount from \$50,000.00 to \$55,000.00.

Section 2. All other sections, terms and provisions of Ordinance No. 5802-2021 not specifically modified or affected by this amending Ordinance shall remain in full force and effect.

Section 3. The cost for said project shall be paid from the appropriate fund.



ORDINANCE NO. 5851-2021

AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE TO ENTER INTO A FIVE-YEAR LEASE AGREEMENT WITH ENTERPRISE FOR A 2022 FORD F-250, NOT TO EXCEED \$35,000.00 FOR THE FIVE-YEAR TERM AND DECLARING AN EMERGENCY.

WHEREAS, the Grounds Maintenance Department currently has a Chevy pick-up truck being used as a maintenance truck; and

WHEREAS, the Chevy pick-up truck was purchased in 2009 with auxiliary equipment; it now has over 70,000 miles and needs to be replaced; and

WHEREAS, it has been determined that leasing a 2022 Ford F-250 with auxiliary equipment will be more cost efficient than purchasing the truck; and

WHEREAS, the City is a member of The Interlocal Purchasing System (TIPS/TAPS) and Enterprise is an authorized vendor.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. The Mayor of the City of North Ridgeville is hereby authorized to enter into a five-year lease agreement with Enterprise for the lease of a 2022 Ford F-250, including auxiliary equipment, not to exceed \$35,000.00 for the five-year term.

Section 2. The cost of leasing the vehicle shall be charged to and paid from the Park and Recreation General Fund.



ORDINANCE NO. 5852-2021

AN ORDINANCE AUTHORIZING THE MAYOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW WITH THE LOWEST AND/OR BEST BIDDER FOR THE REMOVAL AND REPLACEMENT OF THE EXISTING FRONTIER PARK PEDESTRIAN BRIDGE, INCLUDING ANCILLARY WORK, NOT TO EXCEED \$71,800.00 AND DECLARING AN EMERGENCY.

WHEREAS, the existing pedestrian bridge at Frontier Park is over 30 years old, has been repaired multiple times, and now needs to be replaced; and

WHEREAS, the existing pedestrian bridge will be removed, then replaced with a new 8-foot wide pedestrian bridge, including ancillary work.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. The Mayor is hereby authorized to advertise for bids and enter into a contract according to law and in a manner prescribed by law with the lowest and/or best bidder for the removal and replacement of the existing Frontier Park pedestrian bridge, including ancillary work, not to exceed \$71,800.00.

Section 2. The cost of this project shall be charged to and paid from the North Ridgeville Parks and Recreation Improvement Fund.



ORDINANCE NO. 5853-2021

AN ORDINANCE AUTHORIZING THE MAYOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW WITH THE LOWEST AND BEST BIDDER FOR ADDING RESTROOM FACILITIES TO THE SHADY DRIVE BATTING CAGE AREA OF THE SHADY DRIVE COMPLEX, NOT TO EXCEED \$191,500.00 AND DECLARING AN EMERGENCY.

WHEREAS, there are currently no restroom facilities located in the area of the indoor batting cage at the Shady Drive Complex; and

WHEREAS, adding restroom facilities to the batting cage will allow the facility to be used year round; and

WHEREAS, EMD Studios has been retained to engineer and design the restroom in the amount of \$18,500.00.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. The Mayor is hereby authorized to negotiate and enter into a contract, according to law, and in a manner prescribed by law with the lowest and/or best bidder for the addition of a restroom to be located in the area of the indoor batting cage at the Shady Drive Complex, not to exceed \$191,500.00.

Section 2. The cost of this project shall be charged to and paid from the appropriate City fund.


