ORDINANCE NO. 5859-2021

AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE TO PURCHASE A 2022 ONE-TON DUMP TRUCK WITH PLOW AND ACCESSORIES FOR THE SERVICE DEPARTMENT THROUGH THE OHIO COOPERATIVE PURCHASING PROGRAM, OR THE OHIO DEPARTMENT OF TRANSPORTATION COOPERATIVE PURCHASING PROGRAM, AND ENTER INTO CONTRACTS WITH AN OUTSIDE VENDOR(S), NOT TO EXCEED \$99,900.00.

WHEREAS, City Council has approved and appropriated funds for a 2022 One-Ton Dump Truck with Plow and Accessories for the Service Department; and

WHEREAS, the purchases will also involve contracts for the chassis and body from multiple vendors, which shall be selected from the State term schedules of the Ohio Cooperative Purchasing Program or the Ohio Department of Transportation Cooperative Purchasing Program; and

WHEREAS, the dump body and related equipment will be acquired from Gledhill Road Machinery Company, a State term schedule vendor, and passed on to the City by the assembler at the same cost; and

WHEREAS, the dump truck will be assembled by Judco, which is a local vendor that continues to be responsive to the City's needs and can complete vehicles in a timely manner, whereas other vendors have been investigated and are unable to timely complete the vehicles.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. The Mayor is hereby authorized to enter into contracts for the purchase of a 2022 One Ton Dump Truck with Plow and related equipment, and Judco for the assembly of the vehicle listed above for the Service Department from the Ohio Cooperative Purchasing Program or the Ohio Department of Transportation Cooperative Purchasing Program, not to exceed \$99,900.00.

Section 2. The cost of said vehicle and related equipment shall be charged to and paid from the appropriate City fund.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

Section 4. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

ORDINANCE NO. 5860-2021

AN ORDINANCE AUTHORIZING THE MAYOR TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACTS ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW FOR CONSTRUCTION OF THE LORAIN ROAD WATER MAIN EXTENSION, INCLUDING ASSOCIATED WORK AND INSPECTION SERVICES, IN THE CITY OF NORTH RIDGEVILLE, IN AN AMOUNT NOT TO EXCEED \$1,100,000.00.

WHEREAS, the City of North Ridgeville entered into an agreement with Avon Lake Regional Water on July 21, 2017, to develop its own water infrastructure and remove all water service taps from the ETL1 (30" high pressure water line) along the Lorain Road corridor from Lear Nagle Road west to the Ohio Turnpike by the year 2021; and

WHEREAS, the City of North Ridgeville has already authorized the engineering for this project to prepare the necessary construction plans and specifications; and

WHEREAS, the City of North Ridgeville will advertise for bids for construction and for the construction administration and inspection services during the construction phase of this project; and

WHEREAS, the City of North Ridgeville has made the necessary appropriations for this project in the 2021 City Budget, and has allocated \$1,000,000.00 for construction and \$100,000.00 for construction administration and inspection services; and

WHEREAS, plans and bidding documents will be available in the City of North Ridgeville Engineering Department for construction of the Lorain Road Water Main Extension.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

Section 1. The Mayor of the City of North Ridgeville, Ohio, is hereby authorized to advertise for bids and enter into contracts according to law and in a manner prescribed by law for the construction of the Lorain Road Water Main Extension, including associated work, in an amount not to exceed \$1,100,000.00.

Section 2. The cost for the Lorain Road Water Main Extension shall be charged to and paid from the appropriate fund.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
