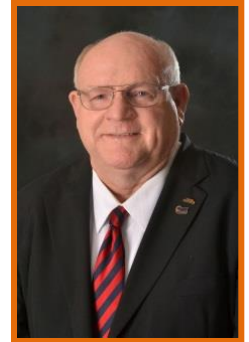

Mayor's Message...

The plans are nearing completion for the Lear Nagle Road Reconstruction Project. The Lorain County Engineer's Office will forward the plans to the Ohio Department of Transportation (ODOT) Central Office in Columbus for final approval and permission to go to bid. Once approved by ODOT, the County Commissioners will proceed with the final approval to go to bid. Bids are tentatively scheduled to go out in October, bid opening in November with work to begin in Spring 2016.

Lorain County Engineer's Office will manage the project. ODOT Safety Funds which provides financing at 100% will be used first. When these funds are depleted, they will start using the 80-20 funding in which the city will be billed for the local share portion as the project proceeds. The city portion has been funded through Bond Anticipation Notes (BANs) to be repaid out of the Street Levy.

This project is finally becoming a reality. Funding for this project was approved by NOACA over 12 years ago before I took office. During an open house at LCCC many years ago, I discovered the funding was on the books but no action had been taken. Upon inquiry, ODOT informed the city they were getting ready to delete it from the approved funding list because of lack of interest. I informed ODOT the city was definitely interested and the project was revived. The city engaged Arcadis Engineering to begin working on the project.

Shortly thereafter, the Lorain County Engineer's Office made available a \$600,000 interest-free loan to finance the engineering needed to complete detailed drawings of the project. At that point, the city began working on how to fund the remainder of the project. The total project cost is \$12,749,977. The city's responsibility is \$3,455,454 which includes \$850,270 for a new water line separate from the road project. The city will realize \$9,294,523 in federal and state funding. Excluding the water line, the city will ultimately pay \$2,605,184 or 20.5% of the total road construction project.

This will be a tremendous improvement for our residents and the city. Anyone who has driven Lear Nagle Road between 6:30-8:30 AM or 4-5:30 PM will appreciate the need for this project to relieve congestion. Anyone who drives Lear Nagle at all will appreciate the need to replace the winter-worn and damaged road with a modern thoroughfare including new water lines, new storm sewers and sidewalks. Adequate turning lanes will also be added at Chestnut Ridge Road and Lear Nagle Road.

DOOR-TO-DOOR ENERGY SOLICITORS

NOPEC has been getting numerous reports of door-to-door solicitors from at least one energy marketer informing residents that their community is no longer a member of NOPEC. This is completely false. North Ridgeville is a member of NOPEC and has been a member since its inception in 2000. NOPEC continues to be North Ridgeville's governmental opt-out aggregator for both natural gas and electricity. If you have a solicitor that gives you false information you can always verify our community's membership in NOPEC by visiting www.nopecinfo.org or by calling NOPEC's customer service number for natural gas at 1-855-667-3201 or electricity at 1-800-292-9284. If you feel you have been moved or slammed to another supplier, you should call your utility company and report it. However, before any supplier can move you to another program you will receive a rescission letter from your utility. You have 7 or 10 days to rescind an enrollment with a supplier you don't want and you will need to call the number provided in the rescission letter.

If you have a complaint about door-to-door solicitors making untrue statements, we would also suggest that you report inappropriate sales behavior to PUCO (Public Utilities Commission of Ohio) at www.puco.ohio.gov or call the PUCO consumer complaint line at 1-800-686-7826.

Mills Road and Route 83, Proposed Roundabout

Through the years the city has been asked, “when are you going to do something about this intersection?” The most recent traffic study conducted in September 2014, completed by ODOT at no cost to the city, suggested widening the intersection with turning lanes or putting in a roundabout. Because this intersection is shared with the City of Avon, discussions soon began with their city officials and an engineering firm that specializes in roundabouts. In the coming weeks, a cooperative agreement with the City of Avon and the necessary legislation will be presented to City Council to move forward with the proposed project.



The projected cost for the roundabout is \$800,000. The cooperative effort with the City of Avon will allow the cities to apply for federal funding and Ohio Public Works Commission funds for the improvements with little or no cost to residents of Avon or North Ridgeville. Moving the intersection slightly to the northeast on property owned by the City of Avon, reduces land acquisition costs for the project, which could not be done by widening the intersection with turning lanes. The projected installation date is summer 2017.

The following quote is provided by the ODOT study regarding the effectiveness of roundabouts, “would provide a decrease in delay for the intersection as it would allow traffic to operate at more of a free-flow condition with the implementation of a roundabout. Roundabouts provide an increase in traffic capacity and provide the highest reduction in crashes as are proven to reduce injury, fatal and overall crashes as compared with a traditional signalized intersection.”

New Fire Station Needed

On November 3, you'll see **Issue #32**, a 20-year .84-mill bond issue on the ballot for consideration. This levy is needed to build/relocate a new headquarters fire station which will replace fire station #1 on Avon Belden Road. If approved, homeowners would see an increase in property taxes of about \$30 a year per \$100,000 of home valuation.

History and Challenges Related to Fire Station #1:

- Fire Station #1 was built in 1957 for an all-volunteer fire force serving less than 8,000 residents. In 1967 the department began full-time staffing and in 1981 an addition was added, but still left the station inadequate. More than fifty years later, the station is now serving nearly 32,000 residents.
- Fire Station #1 is the only full-time fire station in Northeast Ohio that is utilizing a mobile home for living space.
- The current station is undersized and has inadequate restroom facilities for the number of staff.
- Firefighter turnout gear storage is non-existent and the station is lacking apparatus space which leaves expensive equipment outside in the weather.
- The station is located 200 feet from one of the city's busiest intersections with no traffic control devices in place for access/exit from the station.
- The current location is not conducive with the continued growth of the city.
- Fire prevention and training offices are non-existent and the current classroom is makeshift and significantly undersized.
- The station lacks a clean room for medical supplies and equipment, a decontamination room to clean dirty medical equipment and an adequate location to service and fill self-contained breathing apparatus.

Knowing that any replacement for this 58 year-old station needs to be built to last 30 to 50 years into the future, Fire Chief John Reese presented to City Council and Administration a study and plan completed by the Columbus-based architectural firm of Mull and Weithman. The proposed new headquarters fire station would be 22,594 square feet and would cost an estimated \$8.2 million including construction, land acquisition, furniture and equipment and construction contingencies. The relocation of the fire station will also decrease overall average response times and provide for increased safety and efficiency.
