Steps Towards Sidewalks

On August 21, 2023, Council approved an ordinance adopting new requirements for sidewalks within the City of North Ridgeville. The intent of the ordinance was to promote connectivity and walkability by expanding where sidewalks are required and updating standards for sidewalk construction. Some key elements of the ordinance are as follows:

- Previously sidewalks were required for new residential and commercial construction (only new construction). Now, Planning Commission has the ability to require sidewalks when commercial additions are made. Also added was a specific requirement for sidewalks to be constructed along the boundary of development areas that border on public streets.
- Construction requirements for sidewalks were improved. Minimum sidewalk width was increased and a requirement for ADA curb ramps adjacent to crosswalks was added.
- Previously, properties separated by a minimum distance from existing sidewalks or schools could seek approval to waive the sidewalk requirement. Those waiver provisions were removed. In the rare case a property owner meets the burden not to provide a sidewalk, the ordinance requires that owner to pay a "fee in lieu" so funds can be captured for future activities that promote connectivity and walkability in the City.

Total Eclipse

The North Ridgeville Police Department would like to reach out to our citizens to make you aware, if you are not already, of the total solar eclipse that is to occur on April 8, 2024.

A total eclipse is one of the rarest and most spectacular events in nature. During the partial phases just before and after totality, the landscape around you is transformed by eerie dim light and strangely sharp shadows. During totality, the sky becomes as dark as deep twilight, bright stars and planets appear, and the sun's outer atmosphere, called the corona, shines around the black disk of the moon's silhouette. Only people in the direct path of the eclipse will also be able to see the corona, which is also usually obscured by the light of our home star. Changes in temperature, winds, and animal behavior occur during the time around totality. The experience is emotionally powerful and unforgettable.

The last time this event occurred was 1806, and the next one is scheduled for 2444. So, it is truly a once in a lifetime event. Lorain County is one of only nine counties that intersect with the center line of totality with Lorain County being the longest periods of totality and highest viewing demand. Ohio is within a one-day drive of 70% of the U.S. population, meaning travel to Lorain County is within reach to many. Local population in Lorain County could triple or even quadruple.

An influx of population is expected to cause a considerable strain on our traffic patterns, place a huge increase in usage to our cellular towers, possibly causing outages. The large amount of people may cause local businesses to be flooded with customers.

Rest assured, we have already begun planning and preparing for this event. We will continue to update you as the eclipse approaches to ensure the safety and wellbeing of our residents. Winter Fire Safety Considerations

Heating, holiday decorations, winter storms and candles all contribute to an increased risk of fire during the winter months. The North Ridgeville Fire Department would like to pass along to you some winter fire prevention tips from the National Fire Protection Agency and the U.S. Fire Administration.

- Half of all home heating fires occur in December, January and February.
- 1 in every 7 home fires and 1 in every 5 home fire deaths involves heating equipment.
- Keep anything that can burn at least 3 feet from heat sources like fireplaces, wood stoves, radiators or space heaters, and candles.
- Keep portable generators outside, away from windows, and as far away from your home as possible.
- Install and test carbon monoxide alarms at least once a month.
- Plug only 1 heat-producing appliance (like a space heater) into an electrical outlet at a time.
- Have a qualified professional clean and inspect your chimney and vents every year.
- Store cooled ashes in a tightly covered metal container, and keep it outside at least 10 feet from your home and any nearby buildings.

Ridgeville Ready Update

The planning team has been hard at work crafting recommendations and action items for the Ridgeville Ready steering committee to review. Specific recommendations are based upon all of the data and public input collected throughout the process. At the steering committee's October meeting, the group covered topics of economy, mobility and infrastructure, amenities and leadership. At the December meeting, the group will be reacting to recommendations around land use, housing and the town center. Once the recommendations are refined by the steering committee, they will be presented to the community. An online round of public input will allow residents and other stakeholders the opportunity to weigh in before the plan is finalized. Stay tuned for more information regarding this input opportunity. Project Updates

Highlighted below is a brief summary of a few of the capital improvement projects currently underway or planned in the coming months. If you have any questions regarding these projects, please call the Engineering Department at (440) 353-0842.

Fire Hydrant Replacement Project

The City will be replacing numerous fire hydrants on Chestnut Ridge Road, Lorain Road, Island Road, Pitts Boulevard, Wil-Lou Lane, Root Road and Reed Road over the upcoming winter months. Thirty-six fire hydrant assemblies will be replaced in total. Residents that are in close proximity to one of these hydrants may experience a reduction or loss in water pressure for a few hours during the work day. Anyone affected by the project will receive advanced notification when the project gets underway.

Culvert Inspection Project

The City will be categorizing and inspecting all cityowned culverts up to ten feet in diameter and crossing roadways. This will be an annual project to investigate the structural integrity and water flow through the pipes.

All driveway culverts are the responsibility of the property owner to maintain and/or replace per city ordinance. These culverts shall be no less than twelve inches in diameter and in accordance with city standards. Culvert pipes shall be structurally sound and allow water to freely flow with no obstructions. All replacements or repairs will require a permit through the Building Department before work can begin.

Mills Road, Stoney Ridge Road and Avalon Drive Roundabout

The roundabout will be a peanut-shape to improve safety and efficiency and eliminate the current intersection's offset geometry. Utility relocations delayed the project and is anticipated to be bid over the winter with construction expected to begin spring 2024.

Cypress Avenue Extension

The Cypress Avenue Roadway Extension Project will connect Cypress Avenue to Lorain Road just inside the city limits of North Olmsted. The project will include storm sewers, along with a waterline and sanitary sewers. The City intends to bid this project over the winter with construction expected to begin in summer 2024.

Mailbox Inspection

With winter weather approaching, the City wants to ensure the safety of all community members and motorists by keeping the roadways clear of ice and snow. Because of the close proximity of mailboxes to the streets, damage to mailboxes and posts is often times unavoidable. Snow and ice are very heavy and will tend to loosen posts that are in the ground. We are asking your cooperation to inspect your mailbox annually in an effort to prevent damage.

- ✓ Make sure your mailbox post is tightly secured into the ground and there are no signs of rotted wood or rusted parts.
- ✓ Repair any loose parts and tighten the hinges on the door of your mailbox.
- ✓ Keep the path to your mailbox clear.

If your mailbox is knocked over by heavy snow being pushed against it, please contact the Service Department at which time they will investigate to determine if the mailbox/post was physically hit by the city plow. The City does not replace mailboxes unless there is evidence of an actual strike by a city plow making contact with it. Rotted posts will not be replaced by the City as this is the homeowner's responsibility.
