LEGAL NOTICE

Sealed proposals will be received at the office of the Mayor, City Hall, 7307 Avon Belden Road, North Ridgeville, Ohio 44039 until 10:00 AM (Local Time) on September 2, 2014 and will be opened and read immediately thereafter for the:

FRENCH CREEK WASTEWATER TREATMENT PLANT – GENERATOR PROJECT UPGRADE – ELECTRICAL PACKAGE

The contract is based on installing a new 5kV, 2.5MW generator, day tank and paralleling gear furnished by others.

Bidders will be required to use the provided bid form, which will be available along with the bid drawings and specifications from The Brewer-Garrett Company, 6800 Eastland Road, Middleburg Heights, Ohio 44130. Please call 440-865-4632 to acquire the bid documents.

A bid guaranty shall be filed with the bid pursuant to ORC 153.54: Either a bond for the full amount of the bid or a Certified Check, Cashier's Check or letter of credit equal to ten (10) percent of the bid and shall be made payable to "City of North Ridgeville" drawn on a solvent bank, as a guarantee that if the bid is accepted, a contract will be entered into and performed. Bid Bonds and Checks accompanying rejected bids will be returned upon award of contract. In the bidding documents, specific contract requirements shall be completed by the selected vendor. These documents must be provided to the City of North Ridgeville and The Brewer-Garrett Company prior to receiving the contract.

The City of North Ridgeville, Ohio reserves the right to reject any and all bids and to waive any irregularities in bidding.

Each proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity.

Sealed bids must be marked on the front of the envelope: "French Creek Waste Water Treatment Plant – Generator Upgrade Project – Electrical Package."

All suppliers involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of this equipment. Additionally, supplier compliance with the Equal Employment Opportunity requirements of Ohio Administrative Code, Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9, shall be required.

Bidder's must comply with the prevailing wage rates based on Public Improvements in Lorain County and the City of North Ridgeville, Ohio as determined by the Department of Commerce, Division of Labor and Worker Safety, Bureau of Wage and Hour.

The successful bidder will be required to furnish a Payment and Performance Contract Bond in the amount as noted in the bid documents.
