# Mayor's Message...



## **Rate Holiday for Trash Collection**



Good news for our utility customers. Due to the excess balance of funds that are above what is needed for continued operations in the solid waste account, it is the desire of the Administration to return any excess cash balance to our customers in the form of a rate holiday. In accordance with city ordinance #5479-2017, it has been hereby declared by the Mayor that a rate holiday shall be granted for December 2019, where no user charges are to be billed by the City to its residential customers for the monthly trash

collection fee. Normal monthly trash charges will resume on the December 31, 2019 utility bill, which would be for the January 2020 trash collection period. If you have any questions regarding the rate holiday, please call the North Ridgeville Utilities Department at (440) 353-0841.

#### **City Messaging System**

The City of North Ridgeville has contracted with Lorain County Commissioners, administered by Lorain County Office of Emergency Management and Homeland Security, to provide the city and county with a robust, cost-effective emergency notification and general messaging system. The service is free to residents to subscribe to receive messages by way of voice, text, and/or e-mail from the county and from North Ridgeville and other jurisdictions. Examples of messages include, but not limited to, weather alerts, water main breaks, road closures, bulk trash collection reminders, etc. To subscribe, visit the city's website at nridgeville.org and click on "Sign Up for Emergency Alerts" icon.

#### Renewal Levies - Fire, Police and Streets - No New Taxes

Legislation was passed at the November 18<sup>th</sup> City Council meeting to move forward with submitting to the electors of the City of North Ridgeville three important levy renewal issues of existing taxes to be placed on the Primary Election ballot to be held March 17, 2020. Briefly highlighted below are the three issues:

➤ Roads and Bridges Levy – renewal of an existing 1.9-mill tax levy for the purpose of general construction, reconstruction, resurfacing and repair of streets, roads and bridges, for a period of five years.

Police Levy – renewal of an existing 1.95-mill tax levy for the purpose of providing and maintaining motor vehicles, communications, and other equipment used directly in the operation of the Police Department, including payment of salaries of permanent police personnel, for a period of five years.

Fire Levy – renewal of an existing 1.9-mill tax levy for the purpose of providing and maintaining fire apparatus, appliances and buildings and sites therefor and for the payment of

salaries for firefighters, for a period of five years.

These three levies combined generate about \$4.4 million in property tax revenues to the city. It is imperative that the city renew all three levies to continue the services that the residents have come to expect and deserve. Again, all three of these issues are renewal levies and **NOT** an additional tax increase.

# Weather and Safety Tip Reminders

Below are a few reminders to keep you and your family safe during these winter months:

- When snow exceeds two inches within 24 hours, a **Snow Ban** is in effect and **No Parking** is permitted on any city street to allow snow plows to pass.
- \* City Ordinances 660.04 and 660.05 require sidewalks, curbs or gutters to be cleared of snow and ice within a reasonable time, which will ordinarily not exceed 12 hours after any storm during which the snow and ice has accumulated.
- \* The removal and disposal of ice and snow from private drives or parking lots into the city streets or across the street onto a tree lawn is prohibited per City Ordinance 600.04.
- Stay back at least 100 feet when following a snow plow or salt truck.

- When your wipers are on, so should your headlights regardless of the time of day/night.
- Do not allow children to play in or on snow drifts near streets or roadways. Safety first!
- Please make sure fire hydrants are clear of snow and ice.
- When using indoor electric and propane/kerosene heaters, be sure to keep them a safe distance away from combustible materials such as curtains, furniture and flammable items. Propane/kerosene heaters should be utilized in only well-ventilated areas.

# Ranger High Tech Academy Studies Natural Weathering and Erosion in the City



On November 6, 2019, over 40 fourth grade students from the Ranger High-Tech Academy STEM classes were taken by bus to tour examples of natural weathering and erosion in the city. One stop was

the Greenwald Ditch in the Mills Creek Development, where they talked about such issues as bank erosion, stream bed scour, and stream bank vegetation. The tour also included the Aca-



demic Center's stormwater management facilities which aid in preventing erosion to the city's waterways. The tour was led by the Assistant City Engineer, Christina Eavenson.

### **Shady Drive Complex Fitness Trail**

Shady Drive Complex is a 37-acre park that is located off of Sugar Ridge Road and is home to 13 baseball/softball diamonds, an indoor 50 x 100-foot batting cage/multi-purpose facility, two concession stands, three public restroom facilities, playground, covered pavilion and a multi-purpose field. Shady Drive hosts a variety of programs through the year and is home to the Parks & Recreation baseball/softball program. Shady Drive is also rented out by national and local organizations for tournaments and league play.

The Parks & Recreation Department was recently awarded the NatureWorks Grant in the amount of \$67,482 to expand the existing trail at Shady Drive. The current 1/4-mile trail will be extended to a 3/4-mile trail that residents are able to utilize for walking and biking. The total project estimate \$169,000 and will be funded through the grant, Parks Recreation Improvement Fund and the generous donation of \$15,000 from North Ridgeville Heart & Sole Challenge which is guided by the Lorain County Public Health and funded through the United Way. The construction phase is anticipated to begin in Spring 2020.
