## **ORDINANCE(S)**

**5769-2020 AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT, ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW, FOR THE REPLACEMENT OF WATER MAINS AND OTHER APPURTENANCES ON STONEY RIDGE ROAD AND SCHAEFER DRIVE, IN AN AMOUNT NOT TO EXCEED \$1,000,000.00 AND DECLARING AN EMERGENCY.**

**WHEREAS**, there are frequent and numerous water main breaks on Stoney Ridge Road and Schaefer Drive, and the existing eight-inch and six-inch water mains are in need of replacement with a new eight-inch water main along Stoney Ridge Road and Schaefer Drive; and

**WHEREAS**, the City of North Ridgeville Engineering Department has developed the necessary construction plans and specifications for the replacement of water mains along Stoney Ridge Road and Schaefer Drive; and

**WHEREAS**, the City of North Ridgeville has made the necessary appropriations for this project in the 2020 City Budget; and

**WHEREAS**, plans and bidding documents will be available in the City of North Ridgeville Engineering Department for construction of the Stoney Ridge Road and Schaefer Drive Water Main Replacement Project.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** The Mayor of the City of North Ridgeville, Ohio is hereby authorized to advertise for bids and enter into a contract, according to law and in a manner prescribed by law, for the replacement of water mains and other appurtenances on Stoney Ridge Road and Schaefer Drive in an amount not to exceed \$1,000,000.00.

**SECTION 2.** The cost for said water main replacement project shall be paid from the appropriate fund.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, the emergency being in order to move forward with this project as quickly as possible because of the frequent water main breaks in this area. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

**5770-2020      AN ORDINANCE AMENDING N.R.C.O. CHAPTER 1062 CEMETERIES BY DELETING SECTION 1062.09 MONTHLY STATEMENT.**

**WHEREAS,** Section 6 of Ordinance No. 32-60 set the compensation (in 1960) of the Sexton, which at that time was a part-time position; and

**WHEREAS,** Section 6 of Ordinance No. 32-60 reads as follows, in its entirety:

Section 6: - COMPENSATION: For his services, the Sexton shall be paid an hourly rate of \$2.50 per hour for actual time engaged in his duties in the Village Cemeteries.

Assistant Sextons shall be paid for their services at the hourly rate of \$2.25 per hour for the actual time engaged in performance of their duties. Caretakers shall be paid for their services at the hourly rate of \$1.75 per hour for actual time engaged in the performance of their duties.

A monthly statement of time for the time expended by the Sexton, Assistant Sextons and Caretakers shall be furnished by the Sexton to the Village Clerk each month itemizing the hours worked and the services performed.

**WHEREAS,** during the ensuing years, the first two paragraphs of Section 6 have been omitted, leaving only verbiage pertaining to a monthly statement of time, which currently comprises N.R.C.O. Section 1062.09 and reads as follows:

1062.09 MONTHLY STATEMENT. A monthly statement of the time expended by the Sexton, Assistant Sextons and Caretakers shall be furnished by the Sexton to the Auditor, itemizing the hours worked and the services performed.

**WHEREAS**, since the monthly statement pertains to time expended in order to receive payment for services rendered, N.R.C.O. Section 1062.09 should be deleted since wages are no longer calculated in this manner.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** N.R.C.O. Section 1062.09 MONTHLY STATEMENT is hereby deleted.

**SECTION 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

**5771-2020      AN ORDINANCE AMENDING N.R.C.O. SECTION 242.01 SAFETY-SERVICE DIRECTOR; CLASSIFICATION; COMPENSATION; DUTIES.**

**WHEREAS**, N.R.C.O. Section 242.01(b) states the following: “Compensation for the Director shall be established by Council annually”; and

**WHEREAS**, compensation for the Safety Service Director is now determined by Ordinance No. 5596-2018, which establishes compensation and benefits for Department Heads and certain discretionary employees.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** N.R.C.O. Section 242.01 *SAFETY-SERVICE DIRECTOR; CLASSIFICATION; COMPENSATION; DUTIES* is hereby amended as follows:

(b) Compensation for the Director is established by Ordinance No. 5596-2018, and any amendments thereto, which determines the compensation and benefits for Department Heads and certain discretionary employees.

**SECTION 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**5771-2020 Continued**

**SECTION 3.** This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
