RESOLUTION(S)

1469-2019 A RESOLUTION APPROVING THE TRANSFER OF FUNDS FROM THE GENERAL FUND.

WHEREAS, the City Engineer estimates the cost of Ranger Way Extension to be \$1,900,000 and the project needs funding; and

WHEREAS, in order to provide for the partial retirement of the \$1,000,000 bond anticipation notes issued for the purchase of two fire trucks and equipment, it is necessary to provide resources for partial retirement of the notes.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

SECTION 1. The City auditor is authorized to transfer \$800,000 from the General Fund to the Capital Projects Fund and such resources shall be committed for the Ranger Way Extension.

SECTION 2. The City auditor is authorized to transfer \$500,000 from the General Fund to the Income Tax Debt Service Fund and such resources shall be committed for the retirement of principle on the fire trucks and equipment bond anticipation notes.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, and in compliance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 4. This Resolution shall take effect and be in full force from and after the earliest period allowed by law.

1470-2019 A RESOLUTION DECLARING THE OFFICIAL INTENT AND REASONABLE EXPECTATION OF THE CITY OF NORTH RIDGEVILLE, ON BEHALF OF THE STATE OF OHIO (THE BORROWER), TO REIMBURSE ITS OPWC CONCRETE STREETS FUND FOR THE 2019/2020 FULL DEPTH CONCRETE STREET RECONSTRUCTION PROJECT, OPWC PROJECT NUMBER CI53W/CI54W, WITH THE PROCEEDS OF TAX EXEMPT DEBT OF THE STATE OF OHIO AND DECLARING AN EMERGENCY.

WHEREAS, Resolution No. 1429-2018 was passed in support of the eligible grant projects and the submission of the grant request for the Ohio Public Works Project Funding, Round 33; and

WHEREAS, the City of North Ridgeville has been awarded and accepted a grant of \$350,000 and an interest free loan of \$100,000 for the Full-Depth Concrete Street Reconstruction Project.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The City of North Ridgeville reasonably expects to receive a reimbursement for the Full-Depth Concrete Street Reconstruction Project as set forth in Appendix “A” of the Project Agreement with the proceeds of bonds to be issued by the State of Ohio.

SECTION 2. The maximum aggregate principal amount of bonds, other than for cost of issuance, expected to be issued by the State of Ohio for reimbursement to the City of North Ridgeville is \$450,000.

SECTION 3. The City Auditor of the City of North Ridgeville is hereby directed to execute and deliver any and all documents necessary to effectuate the grant and loan on the Ohio Public Works Project funding.

SECTION 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 5. This Resolution is hereby declared to be an emergency measure, the emergency being the need to meet the OPWC deadline. Wherefore, this Resolution shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

ORDINANCE(S)

5680-2019 AN ORDINANCE AMENDING ORDINANCE NUMBER 5595-2018 OF THE CITY OF NORTH RIDGEVILLE, OHIO, PROVIDING SUPPLEMENTAL APPROPRIATIONS FOR THE PERIOD COMMENCING JANUARY 1, 2019 AND ENDING DECEMBER 31, 2019.

WHEREAS, it is necessary to amend the appropriations for certain funds and appropriate other amounts for the operations of the City of North Ridgeville, Ohio.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

SECTION 1. That to provide for current and other expenditures for the City of North Ridgeville, Ohio for the period commencing January 1, 2019 and ending December 31, 2019, Ordinance No. 5595-2018 is hereby supplemented in the following amounts so that from and after the effective date of the Ordinance, the appropriation Ordinance shall include the following, being adjusted for the similar terms in the preceding appropriation Ordinance.

SECTION 2. That there be appropriated the amounts as follows:

SECTION 3. That the Auditor of the City of North Ridgeville is hereby authorized to draw warrants on the Treasury of the City of North Ridgeville for payments on any of the foregoing appropriations, upon receiving proper certification and vouchers therefore, approved by officers authorized by law to approve the same or by an ordinance or resolution of Council to make the expenditure and provide that no warrants may be drawn or paid for salaries or wages, except to persons employed by authority of or in accordance with law or Ordinance.

SECTION 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements.

SECTION 5. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

5681-2019 AN ORDINANCE EXTENDING THE ASSESSMENT EVALUATION OF CIVIL SERVICE PROMOTIONAL EXAMINATIONS TO AFFIRMATIVELY RECOGNIZE SUCH ASSESSMENT FOR THE POSITIONS OF FIRE CHIEF AND ASSISTANT FIRE CHIEF.

WHEREAS, current Civil Service Rules and Regulations provide that if there is a non-written examination, as part of the promotional examination, that score is part of the overall score of the applicant for the position; and

WHEREAS, the Collective Bargaining Agreement for The International Association of Firefighters, Local 2129, AFL-CLO currently provides for an assessment portion which is weighted according to the dictates of the Collective Bargaining Agreement as part of the overall score of the applicant for the position; and

WHEREAS, because the Civil Service Rules and Regulations recognize the non-written assessment as a valuable part of promotional examinations and because the Collective Bargaining Agreements establish the relative weight of such examinations as part of the promotional process, this has become part of the promotional process for the Fire Chief and Assistant Fire Chief; and

WHEREAS, the Administration and the North Ridgeville City Council wish to make it clear that this practice extends to and covers the position of Fire Chief and Assistant Fire Chief and the Civil Service Commission wishes to make this part of their Rules and Regulations.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

SECTION 1. Promotional vacancies for the positions of Fire Chief and Assistant Fire Chief shall be filled by a written competitive exam that comprises not less than sixty percent (60%) of the composite score with the employer having the right to utilize an accredited assessment center and interview process for the remaining portion of the composite score. Applicants for the position shall come from the next lower rank or as allowed by the laws governing Civil Service.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
