### ORDINANCE(S)

### 5497-2017 AN ORDINANCE PROVIDING APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF NORTH RIDGEVILLE, OHIO, FOR THE PERIOD COMMENCING JANUARY 1, 2018 AND ENDING DECEMBER 31, 2018 AND DECLARING AN EMERGENCY.

**WHEREAS**, it is necessary to pass an annual appropriation Ordinance providing for the current expenses and other expenditures of the City of North Ridgeville, Ohio.

# NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

**SECTION 1.** That to provide for current and other expenditures for the City of North Ridgeville, Ohio for the period commencing January 1, 2018 and ending December 31, 2018, the sums presented in **Exhibit "A"** are hereby set aside and appropriated.

**SECTION 2.** That the Auditor of the City of North Ridgeville is hereby authorized to draw warrants and Automated Clearing House transactions on the Treasury of the City of North Ridgeville for payments on any of the foregoing appropriations, upon receiving proper certification and vouchers therefore, approved by officers authorized by law to approve the same or by an ordinance or resolution of Council to make the expenditure and provide that no warrants may be drawn or paid for salaries or wages, except to persons employed by authority of or in accordance with law or Ordinance.

**SECTION 3**. The Auditor is hereby authorized to allocate or reallocate funds to accounts that are within the fund, department, and major objects of expenditure established by the appropriations approved in this Ordinance or in any other Ordinance approved by Council.

**SECTION 4.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in

meetings open to the public in accordance with all legal requirements.

**SECTION 5.** This Ordinance is hereby declared to be an emergency measure, the emergency being the immediate necessity to have the budget in place by January 1, 2018. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

#### 5498-2017 AN ORDINANCE AMENDING ORDINANCE NUMBER 5427-2017 OF THE CITY OF NORTH RIDGEVILLE, OHIO, PROVIDING APPROPRIATIONS FOR THE PERIOD COMMENCING JANUARY 1, 2017 AND ENDING DECEMBER 31, 2017 AND DECLARING AN EMERGENCY.

**WHEREAS**, it is necessary to amend the appropriations for certain funds and appropriate other amounts for the operations of the City of North Ridgeville, Ohio.

# NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

**SECTION 1**. That to provide for current and other expenditures for the City of North Ridgeville, Ohio for the period commencing January 1, 2017 and ending December 31, 2017, Ordinance No. 5427-2017 be and the same are hereby supplemented in the following amounts so that from and after the effective date of the Ordinance, the appropriation Ordinance shall include the following, being adjusted for the similar terms in the preceding appropriation Ordinance.

**SECTION 4.** That the Auditor of the City of North Ridgeville is hereby authorized to draw warrants on the Treasury of the City of North Ridgeville for payments on any of the foregoing appropriations, upon receiving proper certification and vouchers therefore, approved by officers authorized by law to approve the same or by an ordinance or resolution of Council to make the expenditure and provide that no warrants may be drawn or paid for salaries or wages, except to persons employed by authority of or in accordance with law or Ordinance.

**SECTION 5.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements.

**SECTION 6.** This Ordinance is hereby declared to be an emergency measure, the emergency being the need to have the amendments in place by year-end. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

#### 5499-2017 AN ORDINANCE RESTRICTING THE MOTOR VEHICLE TAX IMPOSED IN ORDINANCE 5205-2015 TO THE REPAYMENT OF DEBT FOR THE CENTER RIDGE IMPROVEMENT PROJECT AND DECLARING AN EMERGENCY.

**WHEREAS**, the Council of the City of North Ridgeville, Ohio adopted Ordinance 5205-2015, which as provided in §4504.172 of the Ohio Revised Code, imposed an annual license tax upon the operation of motor vehicles on the public roads in the City for the purpose of construction and maintaining public roads, highways, streets and bridges; and

WHEREAS, the tax is at the rate of five dollars (\$5.00) per motor vehicle registered in the City, and

**WHEREAS**, the tax was imposed for the purpose of constructing and maintaining public roads, highways, streets and bridges, but more specifically to aid in financing the cost of improvements to Center Ridge Road, and

**WHEREAS**, §4504.06 of the Ohio Revised Code, defines the allowable uses of the tax, which includes paying debt service charges on notes or bonds of the City issued for such purposes.

# NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

**SECTION 1.** The City hereby restricts the motor vehicle tax imposed by Ordinance 5205-2015 to the payment of the debt used to finance the improvements to Center Ridge Road until such debt obligations have been satisfied. Following the retirement of all debt and costs incurred by the City for the Center Ridge Road project, the annual license tax collected by the City shall be expended pursuant to §4504.172 of the Ohio Revised Code, and be recorded in the Motor Vehicle License Tax Fund.

**SECTION 2.** The City Auditor and Treasurer shall record the receipts from the tax imposed under §4504.172 of the Ohio Revised Code to the Center Ridge Improvement Fund Debt Service Fund beginning with the receipts for 2017.

**SECTION 3.** That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, and in compliance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, the emergency being the immediate necessity to incorporate the fee into the 2017 and 2018 budget. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
