PID NO. 86700; PROJECT NAME: D03 CRSEAL FY2016; AN ORDINANCE COOPERATING WITH THE DIRECTOR OF THE OHIO DEPARTMENT OF TRANSPORTATION TO PERFORM PREVENTATIVE MAINTENANCE TREATMENT CRACKSEALING ON STATE ROUTE 83 AND DECLARING AN EMERGENCY.

WHEREAS, in the opinion of Council and upon the recommendation of the Ohio Department of Transportation that it would be conducive to the public welfare and safety of the motoring public to perform preventative maintenance treatment cracksealing on State Route 83 from Butternut Ridge Road to Hedgerow Park Drive and from Sugar Ridge Road to Westwood Drive; and

WHEREAS, upon passage of this Ordinance, which has been requested by ODOT to be adopted and delivered by February 12, 2016, the Clerk of Council shall mail two certified copies to Mark Eppley, Transportation Engineer, Planning and Engineering Department, District 3, 906 Clark Avenue, Ashland, OH 44805.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1 – Project Description

The State has identified the need for the described project:

To perform preventative maintenance treatment cracksealing on State Route 83 from Butternut Ridge Road to Hedgerow Park Drive and from Sugar Ridge Road to Westwood Drive.

Approximately 1.10 miles of this project are within the City.

This project is currently scheduled for the summer 2016 construction season.

SECTION II – Consent Statement

Being in the public interest, the City gives consent to the Director of Transportation to complete the above described project.

SECTION III – Cooperation Statement

The City shall cooperate with the Director of Transportation in the above-described project as follows:

- 1) The City gives consent for the above improvement,
- 2) No funds are required from the City except that the City agrees to assume and bear one hundred percent (100%) of the total cost for added construction items requested by the City and not necessary for the improvement as determined by the State and the Federal Highway Administration.

SECTION IV – Maintenance

The City will maintain the right-of-way and keep it free of obstructions and hold said right-of-way inviolate for public highway purposes.

SECTION V – Authority to Sign

The Mayor of said City of North Ridgeville is hereby empowered on behalf of the City of North Ridgeville to enter into contracts with the Director of Transportation necessary to complete the above described project.

SECTION VI – Legal Requirements

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION VII – Effective Date

This Ordinance is hereby declared to be an emergency measure, the emergency being the need to meet the timing deadlines established by ODOT. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

5315-2016 AN ORDINANCE AMENDING AND/OR CREATING CERTAIN DIVISIONS OF N.R.C.O. §618.01 DOGS AND OTHER ANIMALS RUNNING AT LARGE; DANGEROUS AND VICIOUS DOGS.

WHEREAS, the current Ordinance is ambiguous as to the requirement for dogs to be leashed within the public areas of the City.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. Certain divisions of N.R.C.O. §618.01 *Dogs and Other Animals Running at Large; Dangerous and Vicious Dogs* are hereby amended and/or created as stated below in the following sections:

SECTION 2. Division (e) shall be amended to state the following:

(e) No owner, keeper or harborer of any dog shall fail at any time to keep it either physically confined or restrained upon the premises of the owner, keeper or harborer by a leash, tether, adequate fence, supervision or secure enclosure to prevent escape, or under reasonable control of some person. Failure to so confine or restrain shall be evidence of the animal being "at-large."

SECTION 3. A new division (f) is hereby created by inserting the following language:

(f) No owner, keeper or harborer of any dog shall fail at any time while that dog is off the premises of the owner, keeper or harborer, or private property upon which express permission has been granted by the owner fail to maintain control of the dog by an adequate leash. The length of the leash must be no longer than that which is reasonably necessary to prevent the animal from chasing, attacking or coming into uninvited contact with any person, animal or vehicle. An exception to the leash requirement shall be granted during dog training upon lands on which there is adequate open space to avoid danger or disturbance to others, and is conditioned on the owner, keeper or harborer maintaining complete control over the animal at all times.

SECTION 4. The current division (f) shall be relabeled as division (g) and all subsequent divisions shall be relabeled accordingly.

SECTION 5. Division (k) (formerly division (l), shall be amended to state the following:

(k) Whoever violates any of the provisions of divisions (d), (e) or (f) of this section shall be fined not less than twenty-five dollars (\$25.00) or more than one hundred dollars (\$100.00) for a first offense. For each subsequent offense, such person shall be fined not less than seventy-five dollars (\$75.00) nor more than two hundred fifty dollars (\$250.00) and may be imprisoned for not more than thirty (30) days. If the animal at-large has a prior conviction as a dangerous dog, a violation of division (d) of this section is a misdemeanor of the fourth degree and subject to the penalty in Section 698.02. If the animal at-large has a prior conviction as a vicious animal, a violation of division (d) of this section is a

misdemeanor of the first degree and subject to the penalty in Section <u>698.02</u>.

SECTION 6. References to division (f) in divisions (m) (formerly division (l) and division (o) (formerly division n) shall be amended to state division (g).

SECTION 7. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 8. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
