### **ORDINANCE(S)**

5516-2018

AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE, OHIO TO ENTER INTO A CONTRACT WITH THE FRATERNAL ORDER OF POLICE, OHIO LABOR COUNCIL, INC. NORTH RIDGEVILLE DIVISION (DISPATCHERS, PATROLMEN, & PROMOTED UNITS) AND DECLARING AN EMERGENCY.

**WHEREAS**, the Council and Administration of the City of North Ridgeville, Ohio have conducted extensive negotiations with the Fraternal Order of Police, Ohio Labor Council, Inc. North Ridgeville Division (Dispatchers, Patrolmen, & Promoted Units), the bargaining representative for its members and such negotiations have resulted in a tentative agreement between the parties.

## NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** The Mayor is hereby authorized and directed to enter into an agreement with the Fraternal Order of Police, Ohio Labor Council, Inc. North Ridgeville Division (Dispatchers, Patrolmen, & Promoted Units), upon the terms and conditions as substantially (allowing for possible non-substantive grammatical corrections or format adjustments) set forth in **Exhibit "A"** attached hereto and made a part hereof as though fully rewritten herein, on behalf of all of the employees in the bargaining unit.

**SECTION 2.** Said contract shall be effective January 1, 2018, through December 31, 2020 and shall be deemed retroactively effective to that date of commencement as to all terms therein, including wages, as if this ratifying Ordinance was adopted prior to January 1, 2018.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, the emergency being the need to put the contract in place as soon as possible. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

#### 5517-2018

AN ORDINANCE AUTHORIZING THE MAYOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT, ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW, WITH THE LOWEST AND BEST BIDDER FOR THE LUANNE DRIVE PUMP STATION REPLACEMENT PROJECT AND OTHER APPURTENANCES, NOT TO EXCEED \$285,000.00.

**WHEREAS**, the existing sanitary sewer pump station on Luanne Drive is in need of replacement, and it is desired to install a station with submersible pumps and above-ground controls; and

**WHEREAS,** it is also desired to install a Gorman Rupp pump station to match the other stations in the City so that replacement parts for only one manufacturer need to be stocked by the Service Department; and

**WHEREAS**, bidding documents for the construction of the replacement pump station are available for viewing in the Engineering Department for this project.

# NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** The Mayor of the City of North Ridgeville, Ohio, is hereby authorized to advertise for bids and enter into a contract, according to law and in a manner prescribed by law, with the lowest and best bidder for the Luanne Drive Pump Station Replacement Project and other appurtenances in an amount not to exceed \$285,000.00.

**SECTION 2.** The cost for said project shall be paid from the appropriate fund.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

### **RESOLUTIONS**

1419-2018 A RESOLUTION APPROVING ADVANCES FROM THE GENERAL FUND OF THE CITY OF NORTH RIDGEVILLE, OHIO AND DECLARING AN EMERGENCY.

**WHEREAS**, in the City of North Ridgeville, Ohio it becomes necessary for the City's General Fund to advance funds to other funds from time to time with the expectation of repayment.

### NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

**SECTION 1.** That it is hereby approved to advance funds from City's General Fund to the City Garage Fund in the amount of Fifty Thousand Dollars (\$50,000.00) in the year 2018. The advance shall be repaid as funds become available in the City Garage Fund.

**SECTION 2.** That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, and in compliance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 3.** This Resolution is hereby declared to be an emergency measure, the emergency being the need to advance the funds immediately in order to operate since the software is in place. Wherefore, this Resolution shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
