ORDINANCES

(The following Ordinances were passed by City Council on February 3, 2014)

5102-2014 AN ORDINANCE AUTHORIZING THE MAYOR TO NEGOTIATE AND ENTER INTO A CONTRACT ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW WITH BREWER-GARRETT FOR PROFESSIONAL ENGINEERING SERVICES FOR UPGRADING THE BACK-UP GENERATOR AT THE FRENCH CREEK WASTEWATER TREATMENT PLANT, NOT TO EXCEED \$475,000.00.
(Introduced by Mayor Gillock)

WHEREAS, power outages during storms have caused flooding of the wet well and damages to equipment at the French Creek Wastewater Treatment Plant; and

WHEREAS, the existing 500kW backup generator is inadequate for providing basic pumping of high influent flow and proper plant treatment; and

WHEREAS, Brewer-Garrett is a professional engineering firm that will provide the following services for the installation of a 2.5MW back-up generator: Alternative solution development; mechanical engineering; electrical engineering, which includes design development, bid documents, and construction documents; miscellaneous costs/printing/permits; mobilization; construction management, including a project executive and a project manager; safety oversight; testing/ start-up/commissioning/ training; general conditions, which includes travel and legal fees; and project close out, which includes O&M manuals, etc.).

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The Mayor of the City of North Ridgeville, Ohio, is hereby authorized to negotiate and enter into a contract according to law and in a manner prescribed by law with Brewer-Garrett for professional engineering consulting services for the installation of a 2.5MW back-up generator at the French Creek Wastewater Treatment Plant, not to exceed \$475,000.00.

SECTION 2. The costs of this project shall be paid from the appropriate fund.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

RESOLUTIONS

(The following Resolutions were passed by City Council on February 3, 2014)

**1300-2014 A RESOLUTION TO APPROVE THE EXPENDITURE OF FUNDS TO MEDINA SUPPLY
IN THE AMOUNT OF \$3,970.00 AND DECLARING AN EMERGENCY.
(Introduced by Mayor Gillock)**

WHEREAS, O.R.C. §5705.41 provides that City Council may authorize the payment of amounts due, wherein legislation shall be passed within thirty (30) days from receipt of a certificate of the fiscal officer in accordance with O.R.C. §5705.41(D)(1); and

WHEREAS, the fiscal officer does certify that the expenditure was and is properly appropriated and otherwise lawful, sufficient funds were and are available or in the process of collection to the credit of the proper fund, and the funds were and are free from any previous encumbrance; and

WHEREAS, Medina Supply performed emergency repairs to the Stoney Ridge Road culvert, and was a necessary public purpose.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. Council hereby authorizes payment to Town & Country Co-Op, Inc. for the following invoices:

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Resolution is hereby declared to be an emergency measure, the emergency being the immediate necessity to pay the invoice within thirty days. WHEREFORE, this Resolution shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
