ORDINANCE(S)

5438-2017

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT, ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW, WITH A CONSULTING ENGINEERING FIRM FOR PLANS AND SPECIFICATIONS FOR THE MODIFICATION OF THE CENTER RIDGE ROAD WIDENING PLANS TO INCLUDE THREE LANES INSTEAD OF TWO LANES ON JAYCOX ROAD, SOUTH OF THE CENTER RIDGE ROAD INTERSECTION, NOT TO EXCEED \$51,610.00.

WHEREAS, Jaycox Road will be extended from Center Ridge Road to 300 feet south of Center Ridge Road in the Center Ridge Road Widening Project; and

WHEREAS, the City of North Ridgeville is extending Jaycox Road to the new 3-8 School parking lot, and the new Fire Station No. 1 will also be located on the new Jaycox Road; and

WHEREAS, due to the North Ridgeville Fire Department being located on the Jaycox Road extension, a third road lane is needed for emergency access; and

WHEREAS, the City of North Ridgeville has received a proposal from a consulting engineering firm that is under contract to design the Center Ridge Road Widening Project to modify the construction plans to provide three lanes on Jaycox Road (south) at the Center Ridge Road intersection.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The Mayor of the City of North Ridgeville, Ohio, is hereby authorized to enter into a contract according to law and in a manner prescribed by law with a consulting engineering firm to modify the construction plans for the Center Ridge Road Widening Project in an amount not to exceed \$51,610.00.

SECTION 2. The cost of this project hall be charged to and paid from the appropriate City fund.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE TO PURCHASE EQUIPMENT FOR VARIOUS CITY DEPARTMENTS FROM THE STATE BID LIST OR STATE CO-OP, OR TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACTS WITH AN OUTSIDE VENDOR(S), ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW, NOT TO EXCEED THE BELOW STATED PRICES.

WHEREAS, City Council has approved funds for the purchase of equipment for various departments; and

WHEREAS, the following equipment is needed:

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The Mayor is hereby authorized to enter into contracts for the purchase of equipment as listed above for various City departments from the State Bid List or State Co-Op, or to advertise for bids, according to law and in a manner prescribed by law, and enter into contracts with the lowest and best bidder(s), not to exceed the above listed prices.

SECTION 2. The cost of said equipment shall be charged to and paid from the appropriate City fund(s).

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF NORTH RIDGEVILLE TO PURCHASE FIVE NEW POLICE VEHICLES AND RELATED EQUIPMENT FROM THE STATE BID LIST OR CO-OP, OR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT WITH AN OUTSIDE VENDOR, ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW, NOT TO EXCEED \$189,000.00 AND DECLARING AN EMERGENCY.

WHEREAS, City Council has approved and appropriated funds for five replacement vehicles for the Police Department; and

WHEREAS, the purchases will also involve contracts for equipment and materials from multiple vendors, all of which shall be selected from the State of Ohio bid lists or cooperatives of approved and previously bid assets and services, or from vendors offering identical items and/or services at prices less than those appearing on State "bid lists"; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The Mayor is hereby authorized to enter into a contract for the purchase of five new vehicles and necessary equipment for the Police Department from the State Bid List or Co-Op, or from vendors offering prices below that of the State pre-bid forums, or to advertise for bids, according to law and in a manner prescribed by law, and enter into a contract with the lowest and best bidder in the cumulative amount, not to exceed \$189,000.00.

SECTION 2. The cost of the police vehicles and equipment shall be charged to and paid from the appropriate City fund.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure; the emergency being the immediate necessity to provide for the health, safety and welfare of the residents of North Ridgeville. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT, ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW, WITH A CONSULTING ENGINEERING FIRM FOR CONSTRUCTION PHASE SERVICES FOR THE JAYCOX ROAD EXTENSION INCLUDING APPURTENANCES, NOT TO EXCEED \$177,280 AND DECLARING AN EMERGENCY.

WHEREAS, Jaycox Road will be extended from 300 feet south of Center Ridge Road to 1305 feet to the north parking lot of the new 3 through 8 school; and

WHEREAS, the City of North Ridgeville desires to enter into a contract with a consulting engineering firm for the purposes of construction administration in order to manage the construction process and execute the contract.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The Mayor of the City of North Ridgeville, Ohio is hereby authorized to enter into a contract, according to law and in a manner prescribed by law, with a consulting engineering firm for construction phase services for the Jaycox Road Extension Project and other appurtenances in an amount not to exceed \$177,280.00.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure, the emergency being the immediate necessity to have the road completed by August 15, 2017. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
