## **ORDINANCE(S)**

**5749-2020 AN ORDINANCE AMENDING N.R.C.O. SECTION 1650.02 PUBLIC EXHIBITION PERMIT REQUIRED; FEE; BOND; RECORDS AND DECLARING AN EMERGENCY.**

**WHEREAS**, there has been an increased demand for firework permits for ceremonies and festivals; and

**WHEREAS**, the Fire Department must inspect the premises upon which the exhibition will take place and determine that the applicant is a licensed exhibitor of fireworks; and

**WHEREAS**, the Fire Department provides a fire engine on site which is manned with on-duty personnel; and

**WHEREAS**, the Fire Department must also have at least one Fire Safety Inspector on site before, during and after each display, which will result in overtime; and

**WHEREAS**, the fee charged for a fireworks permit is currently \$25.00, as stated below in N.R.C.O. Section 1650.02(c) *Public Exhibition Permit Required; Fee; Bond; Records*: and

- (c) The Fire Chief or Fire Prevention Officer and the Police Chief or similar chief law enforcement officer, or designee of such Police Chief or similar chief law enforcement officer, shall not issue a permit until the applicant pays a permit fee of twenty-five (\$25.00) plus any necessary costs of investigation of the applicant and inspecting the premises on which the exhibition will be conducted.

**WHEREAS**, in order to recoup all or part of the City's costs, the permit fee needs to be amended.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** N.R.C.O. Section 1650.02(c) is hereby amended as follows:

- (c) The Fire Chief or Fire Prevention Officer and the Police Chief or similar chief law enforcement officer, or designee of such Police Chief or similar chief law enforcement officer, shall not issue a permit until the applicant pays a permit fee of twenty-five (\$25.00) plus any necessary costs of investigation of the applicant, inspecting the premises on which the exhibition will be conducted, and the costs associated with time spent before, during and after the exhibition by certified personnel. "See N.R.C.O. Section 1650.02 (e)."

**SECTION 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, the emergency being in order to recoup costs for the increase in displays within the City. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

**5750-2020      AN ORDINANCE AUTHORIZING THE MAYOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT, ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW, WITH THE LOWEST AND BEST BIDDER FOR THE 2020 HYDRANT REPLACEMENT PROJECT, AND OTHER APPURTENANCES, NOT TO EXCEED \$420,000.00 AND DECLARING AN EMERGENCY.**

**WHEREAS,** the City's aging water system is in need of repairs. There are over one hundred fire hydrants and associated valves throughout the City in need of replacement; and

**WHEREAS,** replacements are necessary to create a reliable system of fire hydrants for the City's fire protection system; and

**WHEREAS,** the City of North Ridgeville has appropriated the necessary funds to perform this work; and

**WHEREAS,** the Engineering Department will review the list of hydrants from the Service Department and create the detailed exhibits for the bidding documents; and

**WHEREAS,** the bidding documents and specifications for this project will be available through the Engineering Department.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** The Mayor of the City of North Ridgeville, Ohio, is hereby authorized to advertise for bids and enter into a contract, according to law and in a manner prescribed by law, with the lowest and best bidder for the 2020 Hydrant Replacement Project, and other appurtenances, in an amount not to exceed \$420,000.00.

**SECTION 2.** The cost for said project shall be paid from the appropriate fund.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, the emergency being for the health, safety and welfare of the residents. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

**5751-2020      AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES FOR THE CITY OF NORTH RIDGEVILLE, OHIO.**

**WHEREAS,** the American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2019 supplement to the Code of Ordinances of the City, which supplement contains all ordinances of a general and permanent nature enacted since the prior supplement to the Code of Ordinances; and

**WHEREAS,** American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make reference to sections of the Ohio Revised Code; and

**WHEREAS,** it is the intent of the legislative authority to accept these updated sections in accordance with the changes of the law of the State of Ohio.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:**

**SECTION 1.** That the 2019 supplement to the Code of Ordinances of the City of North Ridgeville as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, and on file in the Clerk of Council's office, be and the same is hereby adopted by reference as if set out in its entirety.

**SECTION 2.** Such supplement shall be deemed published as of the day of its adoption and approval by the legislative authority.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were conducted in an open meeting of this Council, and that all

deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 4.** This ordinance shall take effect and be in full force from and after the earliest period allowed by law.
