5756-2020

AN ORDINANCE ADOPTING AND APPROVING THE TAX BUDGET OF THE CITY OF NORTH RIDGEVILLE, OHIO FOR THE YEAR BEGINNING JANUARY 1, 2021 AND SUBMITTING SAME TO THE LORAIN COUNTY AUDITOR AND DECLARING AN EMERGENCY.

WHEREAS, the Lorain County Budget Commission, pursuant to Ohio Revised Code Section 5705.281, waived the formal tax budget and its adoption required by Section 5705.28, and the public hearing and notice required by Section 5705.30; and

WHEREAS, in lieu of filing the formal tax budget, the Lorain County Budget Commission requested that similar information be filed by July 20, 2020; and

WHEREAS, the Auditor has compiled the requested budget information for the City of North Ridgeville, Ohio for the year beginning January 1, 2021, attached hereto as **Exhibit "A"**; and

WHEREAS, with the approval of the North Ridgeville City Council, the Auditor will file the budget information with the Lorain County Budget Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

SECTION 1. The budget information for the City of North Ridgeville, Ohio for the year beginning January 1, 2021, compiled by the Auditor in the attached **Exhibit "A"** is hereby accepted.

SECTION 2. The Auditor is hereby authorized and directed to file a copy of the said information and this Ordinance with the Auditor of Lorain County, as Secretary of the Lorain County Budget Commission.

SECTION 3. This Ordinance is hereby declared to be an emergency measure, the emergency being in order to meet the filing deadline of July 20, 2020. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

5757-2020 AN ORDINANCE INCREASING SEWER COLLECTION SYSTEM RATES AND AMENDING N.R.C.O. SECTION 1044.01 USER CHARGES AND DECLARING AN EMERGENCY.

WHEREAS, due to a four (4%) percent increase in the wholesale rate charged by the French Creek Wastewater Treatment Plant and due to a rate study performed by AECOM showing that a six (6%) percent increase is needed to fund capital improvements and to keep the sewer revenue fund solvent, it has been determined that a ten (10%) percent sewer rate increase is necessary; and

WHEREAS, the current rate for residential users is \$5.21 per 100 cubic feet; after the ten (10%) percent increase the rate will increase to \$5.73 per 100 cubic feet. The current rate for commercial users is \$5.46 per 100 cubic feet; after the ten (10%) increase the rate will increase to \$6.01 per 100 cubic feet. The monthly base charge of \$9.00 will remain the same for all users.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. Council hereby approves a ten (10%) percent increase in sewer collection system rates, effective August 1, 2020.

SECTION 2. Adjustments to the sewer collection system rates shall be made automatically when the wholesale rates increase/decrease.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure, the emergency being in order to begin collections on August 1, 2020. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A PARTICIPATION AGREEMENT WITH THE OHIO DEPARTMENT OF TRANSPORTATION FOR THE PURCHASE OF RECLAMITE ASPHALT REJUVENATOR FROM THE STATE BID LIST OR STATE CO-OP, OR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT WITH AN OUTSIDE VENDOR, ACCORDING TO LAW AND IN A MANNER PRESECRIBED BY LAW, IN AN AMOUNT NOT TO EXCEED \$100,000.00 AND DECLARING AN EMERGENCY.

WHEREAS, it has been shown that the addition of reclamite asphalt rejuvenator to recently resurfaced asphalt roadways will preserve and extend the pavement life; and

WHEREAS, the City intends to use an outside vendor for the purchase and application of reclamite asphalt rejuvenator from the State bid list; and

WHEREAS, the City will treat roughly 7.75 lane miles of asphalt streets with reclamite asphalt rejuvenator in an amount not to exceed \$100,000.00.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. This Council does hereby authorize the Mayor to enter into a participation agreement with the Ohio Department of Transportation for the purchase of machinery, materials, supplies or other articles, which the Department has entered into pursuant to Ohio Revised Code 5513.01(B), not to exceed \$100,000.00.

SECTION 2. This Council does further authorize the Mayor to be bound by all terms and conditions as the Ohio Director of Transportation prescribes.

SECTION 3. This Council authorizes the Mayor to directly pay the vendor, under each such contract of the Ohio Department of Transportation in which the City of North Ridgeville participates, for items it receives pursuant to the contract.

SECTION 4. The City of North Ridgeville agrees to hold the Ohio Director of Transportation and the Ohio Department of Transportation harmless for any claim or dispute arising out of participation in a contract pursuant to Ohio R.C. 5513.01(B).

SECTION 5. The cost of said reclamite asphalt rejuvenator shall be charged to and paid from the appropriate City fund.

SECTION 6. It is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public and in compliance will all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 7. This Ordinance is hereby declared to be an emergency measure, the emergency being the need to move forward on the project. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
