ORDINANCE(S)

5482-2017 AN ORDINANCE AUTHORIZING THE MAYOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT, ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW, WITH THE LOWEST AND BEST BIDDER FOR THE SUBBASINS 9, 10, 15 and 16 SANITARY SEWER REHABILITATION PROJECT AND OTHER APPURTENANCES, NOT TO EXCEED \$110,000.00 AND DECLARING AN EMERGENCY.

WHEREAS, a City-wide flow monitoring study in 2005 identified the need for sanitary sewer repair and rehabilitation for 14 of the subbasins in the City; and

WHEREAS, as a result of dye testing and televising the sanitary sewer system in Subbasins 9, 10, 15 and 16 in 2016, sewer repair and rehabilitation areas were identified; and

WHEREAS, bidding documents for the construction of the sanitary sewer repairs and rehabilitation for Subbasins 9, 10, 15 and 16 are available in the Engineering Department for this project.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The Mayor of the City of North Ridgeville, Ohio is hereby authorized to advertise for bids and enter into a contract, according to law and in a manner prescribed by law, with the lowest and best bidder for the Subbasins 9, 10, 15 and 16 Sanitary Sewer Rehabilitation Project and other appurtenances in an amount not to exceed \$110,000.00.

SECTION 2. The cost for said project shall be paid from the appropriate fund.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all

deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure, the emergency being for the health, safety, and welfare of the citizens of North Ridgeville. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

RESOLUTION(S)

1409-2017 A FINAL RESOLUTION REGARDING PID NO. 82632, CENTER RIDGE ROAD WIDENENING PROJECT FROM STONEY RIDGE ROAD TO LEAR NAGLE ROAD AND DECLARING AN EMERGENCY.

WHEREAS, the following final Resolution enacted by the City of North Ridgeville, Ohio, hereinafter referred to as the Legislative Authority/Local Public Agency or "LPA", in the matter of the stated described project.

WHEREAS, on the 15th day of June 2015, the LPA enacted legislation (Ordinance No. 5262-2015) proposing cooperation with the Director of Transportation for the described project:

The project consists of widening to five lanes from Stoney Ridge Road to Lear Nagle. The Project includes 2.32 miles of improvements on U.S. 20 by pavement widening from three lanes to five lanes, multi-use paths, sidewalks, storm sewer, traffic signals, and two bridge replacements, lying with the City of North Ridgeville; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one-hundred percent (100%) of the entire cost of the improvement within the City limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U.S. Department of Transportation.

WHEREAS, the share of the cost of the LPA is now estimated in the amount of \$1,654,766.00, but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

WHEREAS, the Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above-described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, the LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

SECTION 1. That the estimated sum of \$1,654,766.00 is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the Treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instances, the share of the cost and expense over and above the amount to be paid from Federal funds.

SECTION. 2. That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

SECTION 3. That the LPA enter into a contract with the State, and that the Mayor be, and is hereby authorized to execute said contract, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.

SECTION 4. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.

SECTION 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 6. This Resolution is hereby declared an emergency. The emergency being the immediate need to meet the deadline set forth by the Ohio Department of Transportation. Wherefore, this Resolution shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
