



LEGAL NOTICE

Sealed proposals will be received at the Office of the Mayor, City Hall, 7307 Avon Belden Road, North Ridgeville, Ohio 44039 until 11:00 A.M. (Local Time) on April 30, 2025 and will be opened and read immediately thereafter for the:

2025 Catch Basin Repairs

The work will consist of all labor and equipment required for the adjustment/reconstruction of various catch basins and concrete blockout replacement and other necessary appurtenances all in accordance with the specifications and contractual requirements now on file in the office of the City Engineer.

The City has appropriated one hundred thirty thousand dollars (\$130,000.00) to perform this work, although this is not a guarantee that all of the appropriated funds will be spent this year.

Bidders will be required to use the bid forms, which will be available along with the bid specifications from the Office of the Engineer, City Hall 7307 Avon Belden Road, North Ridgeville, Ohio 44039. Bid forms are also available electronically upon request. Electronic copies of the bid proposals will be available once proof of payment has been received. Checks shall be made payable to the City of North Ridgeville, Ohio, at a non-refundable cost of fifty dollars (\$50.00). Contact the Engineering Department between the hours of 8 AM to 4:30 PM for further details. No documents will be mailed.

Each proposal shall be accompanied by a bid guarantee which shall consist of a bond in accordance with ORC 153.54 (B) or a certified check, cashier's check or letter of credit in accordance with ORC 153.54 (C). If a bond is submitted it shall be an Ohio Statutory Bid Guaranty and Contract Bond, substantially in the form prescribed by ORC 153.571 in a penal amount equal to or greater than 100% of the bid price. If a bid guarantee is submitted other than in the form of a bond it shall be in an amount equal to 10% of the bid.

The City of North Ridgeville, Ohio reserves the right to reject any or all Bids and to waive any irregularities in bidding. Each proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. Each proposal must contain labels that identify the bid form and the insurance bid bond information.

Sealed bids must be marked on the front of the envelope:

"2025 Catch Basin Repairs"

All questions during bidding shall be emailed to bidinquiries@nridgeville.org. The email should have the project title in the subject line.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the Equal Employment Opportunity requirements of Ohio Administrative Code, Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9, shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Lorain County and the City of North Ridgeville, Ohio, as determined by the Department of Commerce, Division of Labor and Worker Safety, Bureau of Wage and Hour.
