LEGAL NOTICE

Sealed proposals will be received at the Office of the Mayor, City Hall, 7307 Avon Belden Road, North Ridgeville, Ohio 44039 until 2:00P.M. (Local Time) on February 10, 2022 and will be opened and read immediately thereafter for the:

LORAIN ROAD WATER MAIN EXTENSION

The work will consist of the installation of a new twelve inch (12") water main along Lorain Road from Bliss Parkway east to Cook Road for approximately 2,200 linear feet. The project includes the removal of all existing service laterals on the 30" ETL1 Water Transmission main belonging to Avon Lake Regional Water and the re-establishment of the service laterals to the new 12" water main. Ancillary improvements include some storm sewer relocations and repaving portions of intersecting roadways and drive aprons within the project limits.

Bidders will be required to use the bid forms, which will be available along with the bid specifications from the Office of the Engineer, City Hall 7307 Avon Belden Road, North Ridgeville, Ohio 44039. Bid forms are also available electronically upon request. Electronic copies of the bid proposals will be available once proof of payment has been received. Checks shall be made payable to the City of North Ridgeville, Ohio, at a non-refundable cost of seventy-five dollars (\$75.00). Contact the Engineering Department between the hours of 8 AM to 4:30 PM for further details. No documents will be mailed.

Each proposal shall be accompanied by a bid guarantee which shall consist of an Ohio Statutory Bid Guaranty and Contract Bond, substantially in the form prescribed by ORC 153.57 in a penal amount equal to or greater than 100% of the bid price. No other form of bond is acceptable. Bid security furnished in bond form shall be issued by a surety Company or Corporation licensed in the State of Ohio to provide said surety.

The City of North Ridgeville, Ohio reserves the right to reject any or all Bids and to waive any irregularities in bidding.

Each proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. Each proposal must contain labels that identify the bid form and the insurance bid bond information.

Sealed bids must be marked on the front of the envelope: "Lorain Road Water Main Extension"

All questions during bidding shall be emailed to <u>bidinquiries@nridgeville.org</u>. The email should have the project title in the subject line.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the Equal Employment Opportunity requirements of Ohio Administrative Code, Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9, shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Lorain County and the City of North Ridgeville, Ohio, as determined by the Department of Commerce, Division of Labor and Worker Safety, Bureau of Wage and Hour.
