ORDINANCE NO. 5920-2022

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW FOR PROFESSIONAL SERVICES FOR THE MILLS ROAD/JAYCOX ROAD SANITARY SEWER IMPROVEMENT PROJECT, IN AN AMOUNT NOT TO EXCEED \$180,000.00, AND DECLARING AN EMERGENCY.

WHEREAS, the City of North Ridgeville desires to improve sanitary sewer flow into the French Creek Interceptor sewer located at the intersection of Mills Road and Jaycox Road; and

WHEREAS, the City of North Ridgeville also desires to improve the capacity of the City's sanitary sewer main along Mills Road from Jaycox Road to Mills Industrial Parkway; and

WHEREAS, the City of North Ridgeville has witnessed sanitary sewer surcharges at this location in recent years; and

WHEREAS, the City of North Ridgeville believes that by altering the flow pattern of the sanitary sewer as it enters the French Creek Interceptor sewer there will be a reduction in surcharging of the sanitary sewer main along Mills Road; and

WHEREAS, the City of North Ridgeville has received a proposal from a consulting engineering firm to provide professional services including hydraulic modeling, design engineering, and construction plans and specifications for the Mills Road/Jaycox Road Sanitary Sewer Improvement Project.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The Mayor of the City of North Ridgeville, Ohio, is hereby authorized to enter into a contract according to law and in a manner prescribed by law with a consulting engineering firm to provide professional services for the Mills Road/Jaycox Road Sanitary Sewer Improvement Project in an amount not to exceed \$180,000.00.

SECTION 2. The cost of professional services for the Mills Road/Jaycox Road Sanitary Sewer Improvement Project shall be paid from the appropriate fund.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
