SECTION 2. There be and is hereby levied on the tax duplicate of the City of North Ridgeville the rate of each tax necessary to be levied within and without the ten mill limitation as follows in **Exhibit "A"** attached hereto and incorporated herein as reference.

SECTION 3. The Director of Finance is hereby directed to provide a certified copy of this Resolution to the Lorain County Auditor.

SECTION 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

RESOLUTION NO. 1610-2023

A RESOLUTION DECLARING IT NECESSARY TO RENEW AN EXISTING TAX LEVY FOR THE PURPOSE OF PROVIDING FOR AMBULANCE SERVICE AND EMERGENCY MEDICAL CARE AND TO MAINTAIN A PARAMEDIC PROGRAM AND TO EQUIP AND TO OPERATE THE SAME, AND REQUESTING THE LORAIN COUNTY AUDITOR TO CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE CITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY THAT RENEWAL LEVY, PURSUANT TO SECTIONS 5705.03, 5705.19(U) AND 5705.191 OF THE REVISED CODE, AND DECLARING AN EMERGENCY.

WHEREAS, at an election on May 7, 2019, the electors of the City of North Ridgeville approved a 2.25-mill tax levy for the purpose of providing for ambulance service and emergency medical care and to maintain a paramedic program and to equip and to operate the same, for a period of five years; and

WHEREAS, the authority to levy that 2.25-mill tax will expire with the levy on the 2023 duplicate for collection in calendar year 2024; and

WHEREAS, this Council finds that the amount of taxes which may be raised within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of the City and that it is necessary to renew the existing 2.25-mill tax in excess of that limitation for the purpose of providing for ambulance service and emergency medical care and to maintain a paramedic program and to equip and to operate the same; and

WHEREAS, in accordance with Section 5705.03(B)(1), the resolution of this Council as described immediately above must state all of the following, as applicable to the levy: (a) the proposed rate of the tax, expressed in mills for each one dollar of taxable value, or the dollar amount of revenue to be generated by the proposed levy; (b) the purpose of the tax; (c) whether the tax is an additional levy, a renewal or a replacement of an existing tax, a renewal or replacement of an existing tax with an increase or a decrease, a reduction or decrease of an existing tax, or extension of an existing tax to additional territory; (d) the Section of the Revised Code authorizing the submission of the question of the tax; (e) the term of years of the tax or that it is for a continuing period of time; (f) that the tax is to be levied upon the entire territory of the City; (g) the date of the election at which the

question of the tax shall appear on the ballot; (h) that the ballot measure shall be submitted to the entire territory of the City; (i) the tax year in which the tax will first be levied and the calendar year in which it will be first collected; and (j) each county in which the City has territory; and

WHEREAS, in accordance with Section 5705.03(B)(2), upon receipt of a certified copy of a resolution of this Council as described immediately above, the Lorain County Auditor is to certify each of the following, as applicable to the levy: (a) the total current tax valuation of the City; (b) the number of mills for each one dollar of taxable value that is required to generate a specified amount of revenue; (c) either of the following, calculated using the tax list for the current year, and if this is not determined, the estimated amount submitted by the Lorain County Auditor to the County Budget Commission: (i) if the levy is to renew, renew and increase, renew and decrease, reduce or decrease, or extend to additional territory an existing levy that is subject to reduction under Section 319.01 of the Revised Code, the levy's estimated effective rate, calculated using the rate described in Section 5705.03(B)(2)(b) or (d), expressed in dollars, rounded to the nearest dollar, for each one hundred thousand dollars of the County Auditor's appraised value, or (ii) for all other levies, the levy's rate, described in Section 5705.03(B)(2)(b) or (d), expressed in dollars, rounded to the nearest dollar, for each one hundred thousand dollars of the County Auditor's appraised value; (d) the dollar amount of revenue, rounded to the nearest dollar, that would be generated by a specified number of mills for each one dollar of taxable value; and (e) an estimate of the levy's annual collections, rounded to the nearest one thousand dollars, which shall be calculated assuming that the amount of the tax list of the City remains throughout the life of the levy the same as the amount of the tax list for the current year, and if this is not determined, the estimated amount submitted by the County Auditor to the County Budget Commission;

NOW, THEREFORE, be it resolved by the Council of the City of North Ridgeville, County of Lorain, State of Ohio, that:

Section 1. As used in this Resolution and in accordance with Section 5705.03(B)(1)(a) of the Revised Code, "mills" refers to mills for each one dollar of taxable value.

Section 2. This Council declares that (i) it is necessary to renew the City's existing 2.25mill ad valorem property tax outside of the ten-mill limitation for the purpose of providing for ambulance service and emergency medical care and to maintain a paramedic program and to equip and to operate the same, (ii) as authorized by Sections 5705.19(U) and 5705.191 of the Revised Code, it intends to submit the question of that renewal levy to the electors of the entire territory of the City at an election on March 19, 2024, and (iii) the City has territory only in Lorain County. If approved, that tax will be levied upon the entire territory of the City for a period of five years, commencing in tax year 2024, for first collection in calendar year 2025.

Section 3. This Council requests the Lorain County Auditor to certify to it both (i) the total current tax valuation of the City and (ii) the dollar amount of revenue that would be generated by the 2.25-mill renewal levy specified in Section 1.

Section 4. The Clerk of Council of this City is authorized and directed to deliver promptly to the Lorain County Auditor a certified copy of this resolution.

Section 5. This Council finds and determines that all formal actions of this Council and of any of its committees concerning and relating to the adoption of this resolution were taken, and that all deliberations of this Council and of any of its committees that resulted in such formal action were held, in meetings open to the public, in compliance with the law.

Section 6. This resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City, and for the further reason that this resolution must be effective immediately so that it can be timely filed with the County Auditor and additional proceedings taken in order to submit the question of the levy to the electors at an election on March 19, 2024; wherefore, this resolution shall be in full force and effect immediately upon its adoption and approval by the Mayor.

KARRES (PARCEL 14A-WD) FOR THE PURPOSE OF CONSTRUCTING A ROUNDABOUT AT THE INTERSECTION OF STATE ROUTE 83 AND CHESTNUT RIDGE ROAD IN THE CITY OF NORTH RIDGEVILLE, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, the City of North Ridgeville, pursuant to contract with the Ohio Department of Transportation, has undertaken a project to construct a roundabout at the intersection of State Rte. 83 and Chestnut Ridge Road in the City of North Ridgeville; and

WHEREAS, pursuant to the provisions of O.R.C. Chapter 163 and O.R.C. Section 719.04, it is deemed necessary for the City of North Ridgeville to appropriate various interests in real estate in order to construct the State Rte. 83 and Chestnut Ridge Road roundabout project; and

WHEREAS, a portion of real estate owned by Edward Joseph Karres and Gertrude H. Karres has been identified as necessary for the construction of the State Rte. 83 and Chestnut Ridge Road roundabout project; and

WHEREAS, the Notice of Intent to Acquire and Good Faith Offer together with the appraisal, as required by O.R.C. Section 163.04, was not submitted to the property owners because they are both deceased; and

WHEREAS, the subject property is a severed PRO remnant, located at the northeast corner of Avon Belden Rd. (SR 83) and Chestnut Ridge Rd. (a signalized intersection), more specifically described as the east side C/L of R/W for SR. 83 and the northeast side C/L of R/W for Chestnut Ridge Rd., North Ridgeville, Lorain County, OH 44039. The subject site has no address or county auditor parcel number. It is mostly improved with highway infrastructure. All of the improvements other than highway improvements are encroachments located within existing right-of-way. All of the land comprises existing PRO. The subject site is not considered to be a lot of record and is unusable except for highway easement purposes. There have been no sales of the subject property in the past 5 years; and

WHEREAS, the proposed take area for Parcel 14A-WD involves a total taking of PRO area, involving the 0.375-acre larger parcel area already encumbered by existing highway easements. There is no residue. Under Ohio law, when the government appropriates fee title to

land already burdened by a perpetual highway easement (PRO), then only nominal compensation (\$10.00 or less) may be awarded the property owner (3 Ohio Jury Instructions, §301.5[4]). The procedure followed by ODOT is to pay \$1.00 when the District decides to purchase the property rights remaining in an area encumbered by a highway easement. Since there is no usable property to be valued except for PRO, a comparables sales analysis is not applicable, and comparable sales were not utilized. Only nominal compensation for the PRO taken is considered.

WHEREAS, per Right-of-Way plans, this parcel of land is comprised of the existing rightof-way for State Route 83 with the intersection of Chestnut Ridge Road within the original parcel's boundaries. No APN available; and

WHEREAS, Probate cases for both Edward and Gertrude have been filed. Note, the subject property is not part of the inventory for either Edward or Gertrude. Edward and Gertrude conveyed the property, minus the road right-of-way, to Tremaco Corporation in Deed Volume 708, Page 538 prior to their deaths. Next of Kin are Edward J. Karres, Jr., Irene Gandee, L. C. Karres, Loretta Pumphrey and Julian Karres.

A RESOLUTION ACCEPTING FUNDS AS PART OF THE AMERICAN RESCUE PLAN ACT FOR THE OHIO AMBULANCE TRANSPORTATION PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the City of North Ridgeville applied for and has been approved as a recipient of the Ohio Ambulance Transportation Program funding through the Ohio Office of Budget and Management (OBM); and

WHEREAS, the American Rescue Plan Act ("ARPA") (Pub. L. No. 117-2), signed into law March 11, 2021, established the Coronavirus State and Local Fiscal Recovery Funds ("SLFRF"), and appropriated \$350 billion to state, local, and Tribal governments across the country to support their response to and recovery from the COVID-19 public health emergency; and

WHEREAS, pursuant to Section 280.10 of Amended Substitute House Bill 45 ("H.B. 45"), the 134th General Assembly of the State of Ohio appropriated \$20 million in SLFRF funds to OBM in appropriation item 042627, Ohio Ambulance Transportation; and

WHEREAS, pursuant to Section 280.10 of H.B. 45, appropriation item 042627, Ohio Ambulance Transportation, shall be used by OBM to administer grants to any public, not-for-profit, or private ground ambulance transport provider, who submitted claims to the Ohio Department of Medicaid during the current state fiscal year; and

WHEREAS, ambulance transportation providers shall use the funds to provide premium pay to eligible workers following all participation rules as provided in the subrecipient agreement; and

WHEREAS, the City of North Ridgeville shall use the grant award of \$20,081.95 to provide lump-sum premium payments to current Fire Department employees who provided ambulance transportation services during the experience period of January 27, 2020, through the date of the signed resolution ending the national emergency on April 10, 2023. Funds shall be fully expended no later than June 30, 2024.

SECTION 1. City Council finds that it is in the best interest of the City to accept the Ohio Ambulance Transportation Program funds, and hereby authorizes the Mayor to accept the funds.

A RESOLUTION DECLARING IT NECESSARY TO LEVY A RENEWAL TAX IN EXCESS OF THE TEN-MILL LIMITATION FOR CURRENT EXPENSES OF THE LORAIN PUBLIC LIBRARY SYSTEM, INCLUDING THE OPERATION OF A BRANCH LIBRARY LOCATED IN THE CITY OF NORTH RIDGEVILLE, AND DECLARING AN EMERGENCY.

(R.C. Sections 5705.03, 5705.19(D), 5705.25) Renewal Public Library Operating Levy

WHEREAS, the City of North Ridgeville, Ohio (the "City"), is currently levying a 1.91 mill, five-year levy for the purpose of providing for current expenses of the Lorain Public Library System, Lorain County, Ohio, including the operation of a branch library operated in the City (the "Library"), approved by the voters of the City on May 7, 2019, and first placed on the tax list and duplicate in 2019 for collection commencing in 2020, and final collection in 2024 (the "Existing Levy"); and

WHEREAS, the Board of Library Trustees of the Library wishes the City Council of the City to initiate proceedings for the submission to the electors in the entire territory of the City the question of a renewal of the Existing Levy for current expenses of the Lorain Public Library System, including the operation of a branch library located in the City; and

WHEREAS, the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the Library; and

WHEREAS, a resolution declaring the necessity of levying a renewal tax levy outside the ten-mill limitation must be passed and certified to the County Auditor of Lorain County (the "County Auditor") in order to permit the City to consider the levy of such a renewal tax and must request that the County Auditor certify to the City the total current tax valuation of the City, the estimate of the levy's annual collections (rounded to the nearest \$1,000) that will be produced by such renewal tax based on such total taxable value, and the amount of the renewal tax (based on the renewal tax's "estimated effective rate" (as defined in Ohio Revised Code Section 5705.01(Q)), as required by

Ohio Revised Code Section 5705.03(B)(2)(c)(i)) expressed in dollars, rounded to the nearest dollar, for each \$100,000 of the "County Auditor's appraised value" (as defined in Ohio Revised Code Section 5705.01 (P)).

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH RIDGEVILLE, TWO-THIRDS OF ALL OF THE MEMBERS ELECTED THERETO CONCURRING, THAT:

SECTION 1. It is necessary for the City to renew all of the Existing Levy, which is a tax in excess of the ten-mill limitation, for the purpose of providing for current expenses of the Lorain Public Library System, including the operation of a branch library operated in the City.

SECTION 2. As authorized by Ohio Revised Code Section 5705.19(D), the question of such renewal tax levy (the "Renewal Levy") shall be submitted to all of the electors in the entire territory of the City at the election to be held on March 19, 2024. All of the territory of the City is located in Lorain County.

SECTION 3. The Renewal Levy shall be at a rate not exceeding 1.91 mills for each \$1 of taxable value upon the entire territory of the City for five years.

SECTION 4. The Renewal Levy shall include a levy on the tax list and duplicate for the 2024 tax year (commencing in 2024, first due in calendar year 2025) if a majority of the electors voting thereon vote in favor thereof.

SECTION 5. The Finance Director of the City is directed to promptly certify a copy of this Resolution to the County Auditor with instructions for the County Auditor to calculate and certify to the City Council the current total taxable value of the City, the estimated property tax revenue (rounded to the nearest \$1,000) that will be produced by the Renewal Levy based on such total taxable value, and the amount of the Renewal Levy (based on its estimated effective rate) expressed in dollars (rounded to the nearest dollar) for each \$100,000 of the County Auditor's appraised value.

SECTION 6. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
