ORDINANCE NO. 6108-2023

AN ORDINANCE IMPOSING A MORATORIUM ON THE GRANTING OF PERMITS AND ON THE ACCEPTANCE OF PLANNING COMMISSION APPLICATIONS FOR TRUCK TERMINALS AS LISTED IN SECTION 1268.02 PERMITTED AND CONDITIONAL USES OF THE NORTH RIDGEVILLE CODIFIED ORDINANCES FOR A PERIOD NOT TO EXCEED 180 DAYS FROM THE EFFECTIVE DATE OF THIS ORDINANCE, IN ORDER TO ALLOW THE PLANNING COMMISSION AND COUNCIL TO CONSIDER POSSIBLE CHANGES TO USE REGULATIONS IN THE B-3 HIGHWAY COMMERCIAL DISTRICT, AND DECLARING AN EMERGENCY.

WHEREAS, as part of the ongoing master planning effort, City officials have been undertaking a review of the permitted and conditional uses listed in the City's various Business Districts; and

WHEREAS, certain uses may create greater potential negative impacts on surrounding properties in relation to access, traffic control, noise, aesthetics and incompatibility with adjacent residential land uses than other types of uses within the City's Business Districts; therefore it should be carefully considered; and

WHEREAS, Planning Commission and Council require time to undertake review of the current regulations and proposed changes to the North Ridgeville Zoning Code to ensure the safe, efficient and orderly development of property within the City.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. Council hereby imposes a moratorium on the granting of permits and on the acceptance of Planning Commission applications for truck terminals as listed in Section 1268.02 *Permitted and Conditional Uses* of the Zoning Code for a period not to exceed 180 days from the effective date of this ordinance, in order to allow the Planning Commission and Council to consider possible changes to the current use regulations in the B-3 Highway Commercial District.

SECTION 2. During the period of the moratorium, no such permits shall be granted or applications accepted for such use.

SECTION 3. During the period of the moratorium, the Planning Commission and Council shall work diligently to review and recommend any changes to the existing ordinance.

SECTION 4. The moratorium shall be in effect for 180 days from the effective date of this ordinance or until changes are enacted to amend the Codified Ordinances of the City of North Ridgeville or until Council approves legislation explicitly revoking this moratorium, whichever occurs first.

SECTION 5. In all other respects, the North Ridgeville Zoning Code, as amended from time to time, shall remain in full force and effect.

SECTION 6. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including §121.22 of the Ohio Revised Code.

SECTION 7. This Ordinance is hereby declared to be an emergency measure, the emergency being in order to allow the Planning Commission and Council to consider possible changes to use regulations in the B-3 highway commercial district. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

AN ORDINANCE AMENDING ORDINANCE 5961-2022 WHICH AUTHORIZED THE MAYOR TO ENTER INTO A CONTRACT WITH A CONSULTING ENGINEERING FIRM FOR ADDITIONAL DESIGN SERVICES FOR THE MILLS CREEK CONSERVATION AND FLOOD CONTROL PROJECT, BY INCREASING THE PRIOR APPROVED AMOUNT OF \$420,000.00 TO \$507,500.00, AND DECLARING AN EMERGENCY.

WHEREAS, the City provided a counter-offer to one of the parcel owners after reviewing additional documentation provided by the property owner and the City's real estate consultant. An additional \$1,300.00 was offered amending the total acquisition cost to \$253,810.00.

ORDINANCE NO. 6113-2023

AN ORDINANCE AMENDING N.R.C.O. CHAPTER 264 CIVIL SERVICE COMMISSION.

WHEREAS, the North Ridgeville Civil Service Commission needs to expand its Rules and Regulations to include a Fire Department lateral hire program, and to adjust its requirements accordingly; and

WHEREAS, the City of North Ridgeville Fire Department is currently experiencing, and may experience from time to time in the future, an urgent and continuing need to attract additional good and qualified Civil Service candidates in numbers sufficient to fill all existing and anticipated vacancies with high-quality candidates; and

WHEREAS, the City of North Ridgeville, through its Charter, has reserved all home rule powers available to this municipality, and pursuant to that authority wishes to implement the use of lateral hires, also known as lateral transfers, into the City's Civil Service structure; and

WHEREAS, the lateral hire program shall be administered by the Civil Service Commission in keeping with the dictates of the North Ridgeville City Charter at Section 10.4; and

WHEREAS, the basis for appointment to any Civil Service position is, and shall continue to be, the merit and fitness of each candidate as called for by the North Ridgeville City Charter at Section 10.4.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

- **SECTION 1.** The heading of N.R.C.O. Section "264.05 *Lateral Hires*" shall be amended and replaced with the heading "264.05 *Lateral Hires, Police*".
- **SECTION 2.** The heading of N.R.C.O. Section "264.06 *Appropriations*" shall be replaced with the heading "264.06 *Lateral Hires, Fire*".
- **SECTION 3.** The following language shall be added under the heading "264.06 *Lateral Hires, Fire*":

- 1. (a) Applicants must have at least three (3) years of experience as a firefighter/paramedic, or five (5) years of paid part-time experience of no less than two hundred (200) hours per year. Starting pay will reflect three (3) years of experience. All other benefits will be the same as those afforded to a starting firefighter except as otherwise limited or expanded by more specific wording in this ordinance or in any amendment to the lateral hire ordinance(s).
- (b) Seniority will start at the date of hire all benefits afforded to a starting firefighter with the exception of vacation time. Lateral hires who meet the minimum standards for experience listed in (1)(a) above shall immediately be entitled to eighty (80) hours of paid vacation time. If a lateral hire exceeds the above-listed experience then the firefighter shall be entitled to the vacation benefits afforded to firefighters as listed in the current collective bargaining agreement.
- (c) Applicant must possess the following training/certifications: Firefighter I & II and Ohio Paramedic Certification.
 - (d) Applicants shall have a twelve (12)-month probationary period.
- (e) Applicants must pass or possess all other applicable and customary qualifications, including, but not limited to a background check, psychological testing, CVSA, fitness testing and drug testing.
- (f) Entry level lateral hire firefighters shall receive longevity credit equal to the longevity credit each candidate possessed immediately prior to employment with the City of North Ridgeville through the lateral hire process. Adequate proof of same shall be presented with application.
- 2. Any additional rules and regulations necessary to fully implement a lateral hire program shall be made upon the deliberation and vote of the Civil Service Commission to appropriately integrate and allow for the use of lateral hires in the existing Civil Service framework. Additionally, the following shall apply:
- (a) When utilizing lateral hiring for entry level positions, the Civil Service Commission (CSC) shall certify up to seven (7) names to the hiring authority as the certified eligibility list, if available, and up to an additional three (3) names may be reviewed by the hiring authority from the existing current certified lateral hire list, if available. More applicants may be from the certified eligibility list when there are fewer from the lateral list. The goal is to achieve a list of ten (10) names with no more than three from the lateral list, if possible.
- (b) Names on the lateral hire list shall remain active for one (1) year after the date of application, unless the applicant asks for the name to be removed, or unless the name is removed for another satisfactory reason.

- (c) No extra credit will be afforded to lateral hires. However, applicants may utilize both the lateral hire process and the Civil Service entrance examination process simultaneously.
- (d) The Civil Service Commission shall fully develop the lateral hire program and advertise for positions, develop, accept, and maintain applications, forms, and all related paperwork. It shall set a reasonable fee for the application process.
- (e) The Civil Service Commission shall communicate with applicants; maintain the integrity of the process; review all applications for completeness; develop a lateral hire list for the appointing authority; and adjust the existing Civil Service Commission rules and regulations to take into account the use of a lateral hire program.
- 3. To the extent practicable, lateral hires will be required to follow or to approximate the same requirements as all other eligible Civil Service candidates.
- 4. The lateral hire program shall remain as a hiring option until and unless ended by a majority vote of Council. However, upon the request of the Fire Chief and upon deliberation and vote of the CSC, or upon the deliberation and vote of the CSC alone, the lateral hiring option may be by-passed and is not required to be used with every hiring cycle.
- **SECTION 6.** N.R.C.O. Section "264.06 Appropriations" that was replaced in Section 2 above, will now be known as N.R.C.O. Section "264.07 Appropriations".
- **SECTION 7.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 8. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.

WHEREAS, on October 2, 2023, the City Council of the City of North Ridgeville, Ohio (the "City"), passed a resolution declaring the necessity to renew for five years all of a tax in excess of the ten-mill limitation in the amount of 1.91 mills for each \$1 of taxable value, for the purpose of current expenses of the Lorain Public Library System (the "Library"), including the operation of a branch library located in the City (the "Renewal Levy"); and

WHEREAS, the County Auditor of Lorain County, Ohio (the "County Auditor"), has certified to the City Council that the dollar amount of revenue that would be generated by the Renewal Levy during the first year of collection is \$ 1,563,000, based on the current total taxable value of the City of \$1,204,166,080; and

WHEREAS, the County Auditor has also certified to the City Council that the amount of the Renewal Levy (based on the Renewal Levy's "estimated effective rate" (as defined in Ohio Revised Code Section 5705.01(Q), as required by Ohio Revised Code Section 5705.03(B)(2)(c)(i)) expressed in dollars, rounded to the nearest dollar, for each \$100,000 of the "County Auditor's appraised value" (as defined in Ohio Revised Code Section 5705.01(P)), is \$44 (the "Estimated Cost").

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH RIDGEVILLE, OHIO, TWO-THIRDS OF ALL OF THE MEMBERS ELECTED THERETO CONCURRING, THAT:

SECTION 1. The City shall proceed with the submission of the question of the Renewal Levy to all of the electors of the City at the rate of 1.91 mills for each \$1 of taxable value for five years, for the purpose of current expenses of the Lorain Public Library System, including the operation of a branch library located in the City, which the County Auditor has certified at the Estimated Cost for each \$100,000 of the County Auditor's appraised value.

SECTION 2. As authorized by Ohio Revised Code Section 5705.19(D), the question of the Renewal Levy shall be submitted to all of the electors in the entire territory of the City at the election to be held on March 19, 2024 (the "Election Date"). All the territory of the City is in Lorain County.

SECTION 3. Such renewal tax levy shall be at a rate not exceeding 1.91 mills for each one dollar of valuation, for each \$1 of taxable value upon the entire territory of the City, for five years.

SECTION 4. Such renewal levy shall be placed upon the tax list and duplicate for the 2024 tax year, beginning in 2024, first due in calendar year 2025, if a majority of the electors voting thereon vote in favor thereof.

SECTION 5. The form of the ballot to be used at said election shall be substantially as follows:

A renewal of a tax for the benefit of the Lorain Public Library System for the purpose of current expenses, including the operation of a branch library located in the City North Ridgeville, that the County Auditor estimates will collect \$1,563,000 annually, at a rate not exceeding 1.91 mills for each \$1 of taxable value, which amounts to \$44 for each \$100,000 of the County Auditor's appraised value, for five years, commencing in 2024, first due in calendar year 2025.

FOR THE TAX LEVY
AGAINST THE TAX LEVY

SECTION 6. This Council finds, determines and declares that the levy of the tax, if approved by the electors, is necessary to the proper furnishing and rendering of free public library services in the City and for the residents of the City.

SECTION 7. Pursuant to Section 3375.42, Ohio Revised Code, this City hereby finds and determines it to be necessary to enter into an agreement with the Library relating to the operation of the North Ridgeville Branch of the Library and to the use of the proceeds of the renewal tax levy to be voted on by the electors as contemplated in this resolution and of other funds available for the operation of the North Ridgeville Branch of the Library. That agreement shall be in substantially the same form attached hereto as **Exhibit A** (the "Agreement").

SECTION 8. The Agreement is hereby approved in substantially the same form attached hereto as **Exhibit A**, with such changes therein as are not inconsistent with this resolution and not substantially adverse to the Council as shall be approved by the officers executing the Agreement, provided that the approval of those changes by those officers, and their character as not being substantially adverse to the Council, shall be evidenced conclusively by their execution of that Agreement.

SECTION 9. The Mayor and Finance Director of the City are hereby authorized and directed, for and in the name and on behalf of this City, to execute and deliver the Agreement in substantially the form attached hereto as Exhibit A.

SECTION 10. The Clerk of Council is hereby directed and shall also certify to the Board of Elections that the Renewal Levy will be levied for five years and will include a levy on the tax list and duplicate for the 2024 tax year (commencing in 2024, first due in calendar year, if approved by a majority of the electors voting thereon.

SECTION 11. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 111.22 of the Ohio Revised Code.

SECTION 12. This resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City, and for the further reason that this resolution must be effective immediately so that it can be timely filed with the County Auditor and additional proceedings taken in order to submit the question of the levy to the electors at an election on March 19, 2024; wherefore, this resolution shall be in full force and effect immediately upon its adoption and approval by the Mayor.

EXHIBIT A

AGREEMENT

This Agreement dated as of ________, 2024, by and between the City of North Ridgeville, Ohio (the "City"), and the Board of Library Trustees (the "Board") of the Lorain Public Library System.

WITNESSETH:

WHEREAS, the Board has maintained since prior to September 4, 1947, and continues to maintain a free public library, with a branch situated in the City, free and open to all of the inhabitants of the City; and

WHEREAS, the Board and the City desire to obtain and raise funds for the operation of the North Ridgeville Branch of the Lorain Public Library System, with the renewal of an existing tax levy.

NOW, THEREFORE, in consideration of the mutual promises hereinafter set forth and other good and valuable consideration, the parties hereto agree as follows:

1. The City agrees to submit, on the ballot at the March 19, 2024 election, the question of a renewal tax levy upon the entire territory of the City, at a rate not exceeding 1.91 mills for each \$1 of taxable value which amounts to \$44 for each \$100,000 of the County

Auditor's appraised value, for five years (the "Tax Levy") for the purpose of the current expenses of the Lorain Public Library, including operation of a branch library located in the City. Pursuant to Section 3375.42, Ohio Revised Code, the City further agrees that, in the event the Tax Levy is approved by the voters of the City, it will provide for the collection of the Tax Levy and disburse all proceeds of the Tax Levy to the Board. All the territory of the City is in Lorain County.

- 2. The Board agrees that all funds raised and paid to the Board from the collection of the Tax Levy will be expended for the operation of the North Ridgeville Branch of the Lorain Public Library.
- 3. The Board further agrees to provide to the City Council of the City, at least once a year during the period of the collection the Tax Levy, an itemized report as to the expenditure of the moneys derived from the Tax Levy.
- 4. The parties mutually agree that any equipment or materials purchased by the Board from the moneys derived from the Tax Levy shall remain the property of the Board for use in the City by the North Ridgeville Branch.
- 5. In the event that the Board shall consolidate with or transfer all of its assets to another public library system governed by the provisions of Chapter 3375, Ohio Revised Code, the rights and obligations under this Agreement shall inure to and become the rights and obligations of the resulting public library system for the benefit of the branch of that public library located in the City.

RESOLUTION NO. 1620-2023

A RESOLUTION SUBMITTING TO THE ELECTORS OF THE CITY OF NORTH RIDGEVILLE THE QUESTION OF RENEWING AN EXISTING 2.25-MILL TAX LEVY FOR FIVE (5) YEARS FOR THE PURPOSE OF PROVIDING FOR AMBULANCE SERVICE AND EMERGENCY MEDICAL CARE AND TO MAINTAIN A PARAMEDIC PROGRAM AND TO EQUIP AND TO OPERATE THE SAME FOR THAT PURPOSE, PURSUANT TO SECTIONS 5705.19(U) AND 5705.191 OF THE REVISED CODE, AND DECLARING AN EMERGENCY.

WHEREAS, at an election held on May 7, 2019, the electors of the City of North Ridgeville approved a 2.25-mill tax levy for the purpose of providing for ambulance service and emergency medical care and to maintain a paramedic program and to equip and to operate the same, for a period of five (5) years; and

WHEREAS, the authority to levy that 2.25-mill tax will expire with the levy on the 2023 duplicate for collection in calendar year 2024; and

WHEREAS, this Council has determined that the renewal of that tax upon its expiration is necessary for the ambulance service and emergency medical care and to maintain a paramedic program and to equip and to operate the same in the City of North Ridgeville, Ohio; and

WHEREAS, on October 16, 2023, this Council adopted Resolution No. 1610-2023 pursuant to Section 5705.03 of the Revised Code declaring it necessary to renew an existing 2.25-mill tax levy for the purpose of providing for ambulance service and emergency medical care and to maintain a paramedic program and to equip and to operate the same for that purpose, a copy of which Resolution was certified to the Lorain County Auditor; and

WHEREAS, in accordance with that Resolution and Section 5705.03(B) of the Revised Code, on November 6, 2023, the Lorain County Auditor certified (on DTE 140R) that (i) the property tax revenue that will be produced by the stated millage (2.25 mills), assuming the taxable value of the City remains constant throughout the life of the levy, is calculated to be \$2,029,000, (ii) the total taxable value of the City used in calculating the estimated property tax revenue is \$1,204,166,080 and (iii) the millage required for the requested levy is 2.25 mills per \$1 of taxable value, which amounts to \$57.00 for each \$100,000 of the County Auditor's appraised value;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of North Ridgeville, County of Lorain, State of Ohio, not less than two-thirds of all members of said Council elected thereto concurring, that:

Section 1. This Council finds, determines and declares that the amount of taxes which may be raised by the City of North Ridgeville within the ten-mill limitation by levies on the current tax list and duplicate will be insufficient to provide an adequate amount for the necessary requirements of this City, and that it is necessary to levy a tax in excess of that limitation for the purpose of providing for ambulance service and emergency medical care and to maintain a paramedic program and to equip and to operate the same, being a purpose set forth in Section 5705.19(U) of the Revised Code, and specifically that it is necessary to renew in its entirety the existing 2.25-mill tax levy approved by the voters of the City at an election on May 7, 2019, for that purpose for a period of five years.

Section 2. The question of renewing the City's existing 2.25-mill ad valorem property tax levy outside the ten-mill limitation for the purpose of providing for ambulance service and emergency medical care and to maintain a paramedic program and to equip and to operate the same for a period of five years, beginning with the tax list and duplicate for the year 2024, the proceeds of which levy first would be due and collected and made available to the City in calendar year 2025, shall be submitted under the provisions of Sections 5705.19(U) and 5705.191 of the Revised Code to the electors of the City of North Ridgeville at an election to be held therein on March 19, 2024, as authorized by law. That election shall be held at the regular places of voting in this City as established by the Board of Elections of Lorain County, or otherwise, within the times provided by law and shall be conducted, canvassed and certified in the manner provided by law. A majority vote is required for passage of that levy.

Section 3. The Clerk of Council is hereby authorized and directed to give or cause to be given notice of that election as provided by law.

Section 4. The Clerk of Council is hereby further directed to deliver or cause to be delivered to the Lorain County Board of Elections before the close of business on Wednesday, December 20, 2023: (i) a certified copy of Resolution No. 1610-2023, adopted on October 16, 2023, (ii) a copy of the related County Auditor's certificate referred to in the fifth preamble to this resolution (and if that certificate is later replaced or reissued by the County Auditor, then the replaced or reissued version) and (iii) a certified copy of this resolution.

Section 5. This Council finds and determines that all formal actions of this Council and of any of its committees concerning and relating to the adoption of this resolution were taken, and that all deliberations of this Council and of any of its committees that resulted in those formal actions were held, in meetings open to the public, in compliance with the law.

Section 6. WHEREAS, the Project site is located at 36516 and 36536 Center Ridge Road, North Ridgeville, Ohio 44039 (the "Property"), and in the North Ridgeville School District, the Lorain County Joint Vocational School District, and the Board of Education of the City of North Ridgeville who had all been notified in accordance with Section 5709.83 of the Ohio Revised Code or have otherwise agreed to the Original Agreement by separately executed contract to consent to the City's execution of the Original Agreement; and

WHEREAS, the Property Owner's name and address was and remains North Ridgeville Technology Group, LLC, ATTN William R. Scott, 206 Saint Andrews Lane, Aurora, Ohio 44202, and needs to be corrected in said Agreement, including as signatory to the Agreement; and

WHEREAS, an affiliate of the Property Owner desires to sell the business operated at the Property (the "Business" and such sale, the "Transaction"), but the Property Owner will retain ownership of the Property; and

WHEREAS, the Parties agree that for the Property Owner to continue to receive the benefits of the Community Reinvestment Area Agreement, the Property Owner, Young Explorers, and/or the new tenant and proposed owner of the Business, Fairlawn Advantage, Inc. c/o BrightPath Kids, with an address of 3280 Bloor Street West; Centre Tower, Suite 410; Toronto,

Ontario M8X 2X3; will continue with the day-to-day operations and agree to abide by the terms and conditions set forth in the Agreement once the Transaction is consummated; and

WHEREAS, the Parties agree that if the Property Owner, Young Explorers, and/or the new tenant and owner of the Business, Fairlawn Advantage, Inc. c/o BrightPath Kids, fails to continue with the day-to-day operations and/or comply with the terms and conditions set forth in the Agreement, the City North Ridgeville may terminate or modify the exemptions from taxation granted under this Agreement in a manner set forth in the Agreement; and

WHEREAS, if the Property Owner, Young Explorers, or the new tenant/business owner materially fails to fulfill its obligations under this Agreement, or if the City determines that the certification as to delinquent taxes required by this Agreement are false or fraudulent, the City may terminate or modify the exemptions from taxation granted under this Agreement, and may require the repayment of the amount of taxes that would have been payable had the property not been exempted from taxation under this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, promises, conditions, and terms of this Addendum, the Parties agree as follows:

- 1. The Property Owner's name and address on the Community Reinvestment Area Agreement is changed to: North Ridgeville Technology Group, LLC, ATTN William R. Scott, 206 Saint Andrews Lane, Aurora, Ohio 44202.
- 2. The Parties agree that for the Property Owner to continue to receive the benefits of the Community Reinvestment Area Agreement, the Property Owner, Young Explorers, and/or the new tenant and owner of the Business, Fairlawn Advantage, Inc. c/o BrightPath Kids, with an address of 3280 Bloor Street West; Centre Tower, Suite 410; Toronto, Ontario M8X 2X3; will continue with the day-to-day operations and will abide by and the terms and conditions set forth in the Agreement.
- 3. The Parties agree that if the Property Owner, Young Explorers, and/or the new owner of the Business, Fairlawn Advantage, Inc. c/o BrightPath Kids, fails to continue with the day-to-day operations and/or comply with the terms and conditions set forth in the Community Reinvestment Area Agreement, the City of North Ridgeville may terminate or modify the exemptions from taxation granted under the Agreement and in a manner set forth in the Agreement.
- 4. If the Property Owner, Young Explorers, and/or new tenant/business owner materially fails to fulfill its obligations under the Agreement, or if the City of North Ridgeville determines that the certification as to delinquent taxes required by the Agreement are false or fraudulent, the City of North Ridgeville may terminate or modify the exemptions from taxation granted under the Agreement, and may require the repayment of the amount of taxes that would have been payable had the property not been exempted from taxation under this Agreement.
- 5. For avoidance of doubt, Young Explorers (or its affiliates) may continue their existing operations at the Property and responsibilities in compliance with the Original Agreement

unless and until the Transaction formally closes, and the inclusion of the new tenant and proposed owner of the Business, Fairlawn Advantage, Inc. c/o BrightPath Kids, with an address of 3280 Bloor Street West; Centre Tower, Suite 410; Toronto, Ontario M8X 2X3 in Sections 2-4 hereof shall expressly be contingent on the Transaction closing, at which time Young Explorers shall be removed as an obligated party under Sections 2-4 hereof.
