#### **ORDINANCE NO. 5960-2022**

# AN ORDINANCE AMENDING ORDINANCE NO. 5952-2022, WHICH REPEALED AND REPLACED N.R.C.O. CHAPTER 264, CIVIL SERVICE COMMISSION, AND DECLARING AN EMERGENCY.

**WHEREAS,** the North Ridgeville City Council recently adopted Ordinance No. 5952-2022, which repealed and replaced N.R.C.O. Chapter 264, *Civil Service Commission;* and

**WHEREAS,** Ordinance No. 5952-2022 was submitted to Council under the then adopted Police Collective Bargaining Agreement, which agreement recently has been updated; and

**WHEREAS,** under the new and current Police Collective Bargaining Agreement, the level of patrol officer for purposes of lateral hires has changed; and

**WHEREAS**, the Chief of Police desires to make clear the distinction between OPOTA trained and OPOTA certified for lateral hiring purposes because an applicant might receive the training without becoming certified; and

**WHEREAS,** the recently adopted legislation, in particular Section 264.05 Lateral Hires, which currently reads as follows, should be amended to precisely reflect these minor changes.

#### 264.05 <u>LATERAL HIRES.</u>

- 1. (a) Applicants must have at least three (3) years of experience as a police officer, or five (5) years of paid part-time experience of no less than 200 hours per year. Starting pay will reflect three years of experience as, a Class A Patrol Officer. All other benefits will be the benefits afforded to a starting police officer.
  - (b) Seniority will start at the date of hire.
  - (c) Applicants must be OPOTA trained.
  - (d) Applicants will have a one-year probationary period which will begin after field training is completed.

(e) Applicants must be an American citizen, a resident of Ohio, and must pass all other applicable and customary qualifications, including but not limited to, a background check, CVSA testing, and fitness testing.

## NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** Section 264.05 Lateral Hires, at subsection 1. (a) Starting pay reflecting three (3) years of experience shall be amended from "Class A Patrol Officer" to "Class B Patrol Officer" to reflect the changes of the most recently negotiated police collective bargaining agreement.

**SECTION 2.** The verbiage "Starting pay reflecting part-time experience of no less than 200 hours per year shall start as a Class A officer" shall be added to subsection 1. (a).

**SECTION 3.** Section 264.05 Lateral Hires, at subsection 1. (c) shall be amended to strike the word "trained" and to replace it with the word "certified".

**SECTION 4.** All other sections, terms, and provisions of Ordinance No. 5952-2022 not specifically modified or affected by this amending Ordinance shall remain in full force and effect.

**SECTION 5.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 6.** This Ordinance is hereby declared to be an emergency measure, the emergency being in order to be in line with the current union contract. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

#### **ORDINANCE NO. 5961-2022**

- **SECTION 1.** Ordinance No. 5536-2019 is hereby amended by increasing the prior approved amount from \$372,000.00 to \$420,000.00.
- **SECTION 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- **SECTION 3.** This Ordinance is hereby declared to be an emergency measure, the emergency being in order to allow the city of North Ridgeville to finalize the plans and move this project forward to the construction phase. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT ACCORDING TO LAW AND IN A MANNER PRESCRIBED BY LAW WITH A CONSULTING ENGINEERING FIRM FOR THE CITY OF NORTH RIDGEVILLE SANITARY SEWER MASTER PLAN UPDATE, NOT TO EXCEED \$350,000.00, AND DECLARING AN EMERGENCY.

**SECTION 1.** The Mayor of the city of North Ridgeville, Ohio, is hereby authorized to enter into a contract according to law and in a manner prescribed by law with a consulting engineering firm to gather and provide the necessary data and subsequent reports for the city of North Ridgeville Sanitary Sewer Master Plan Update, in an amount not to exceed \$350,000.00.

**SECTION 2.** The cost of this project shall be charged to and paid from the appropriate fund.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, the emergency being in order to get the project started. Wherefore, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor.

#### **ORDINANCE NO. 5965-2022**

### AN ORDINANCE ACCEPTING CERTAIN STREETS/IMPROVEMENTS LOCATED IN THE RESERVE AT WINFIELD FARM SUBDIVISION PHASE 2, AND DEDICATING THEM FOR PUBLIC PURPOSES.

# NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

**SECTION 1.** City Council hereby accepts the following streets/improvements from The Meritage Group, LP, located in the Reserve at Winfield Farm Subdivision Phase 2, and hereby dedicates said streets/improvements for public use and maintenance, including but not limited to roadways, sidewalks, drainage and utility purposes:
