- Certificate of Insurance with a minimum \$500,000, \$1 million liability, \$10,000 property damage with effective and expiration dates, directed to the City of North Ridgeville;
- Affidavit showing contractor has a minimum two (2) year of experience;
- Application Fee (checks payable to City of North Ridgeville); and
- Self-Addressed Stamped Envelope, if you would like the registration certificate mailed to you.
