

Last July the administration had to give an estimate to County officials of our 2011 budget. I don't really put a lot of credibility into that estimate because I know things can change in six months. Little did I know how complicated planning our budget would actually be by the end of February when we sat down with Council and hammered it out. But three significant things happened that leave us in the position of feeling our way through to the end of the year to see where we really are.

The first major impact was the renewal of our three union contracts with our police, fire and other employees. While negotiations are always tough, in the past, after one union settlement was reached the other two typically fell in line. This year we ended up with three different contracts with different terms and different lengths. The police contract is one year, the fire is two years and AFSCME is a three year contract.

Secondly, Ohio Senate Bill 5 was passed which can cause tremendous changes in our collective bargaining agreements. I believe that even the thought that SB 5 would be passed had an effect

on getting our contracts settled. And while SB 5 might not become effective until November, or even never, the collective bargaining landscape has changed.

And finally, Governor Kasich's budget has been proposed. No one knows right now what the final budget bill will look like. But again, cuts into the Local Government Fund Revenues, elimination of the reimbursement of lost tangible property taxes (supposed to be replaced by the CAT tax, but that hasn't occurred either) will have a major impact on our end of the year numbers.

We are always conservative, and our employees made a huge sacrifice. SB 5 is not law yet and the State budget won't take effect until July 1, 2011, so I'm sure we will manage this year okay. Unfortunately, it is getting more difficult all the time to predict where our funding will be to maintain roads, fix sewers and pay employees. But, though times are tough, I still love my job, the employees I work with and the residents I serve. North Ridgeville is still an outstanding place to live, work and play. I am a very lucky person.

### **Backflow Prevention Requirements**

Your private irrigation system or in-ground swimming pool is required to be fitted with an ASSE 1020 or 1013 Backflow Prevention Device that *must be tested at the time your system is installed and every 12 months thereafter, even if the system is not in use.* A state certified person must test backflow devices. Most local plumbers have personnel who can perform this test if your contractor has no one certified on staff. Please obtain a copy of this completed test for your records and submit a copy to the Engineering Department. This is not the contractor's responsibility, however, some will submit the test to the city on your behalf. To be safe, please confirm with Engineering that this has been done.

When choosing a contractor, be sure they are familiar with these backflow prevention requirements before signing an agreement. Also, for your protection, verify through the North Ridgeville Building Department at 353-0822 that your contractor is currently registered with the city before agreeing to any work. The Backflow Prevention Program, as described by Ohio Administrative Code 3745-95-02(a) and North Ridgeville Ordinance 1046.22, can be found online at the City of North Ridgeville website: www.nridgeville.org. ## **Improving Drainage in North Ridgeville**

As I am sure a lot of residents of North Ridgeville are painfully aware, our city was subjected to a "Perfect Storm" early Monday, February 28. While all the conditions that contributed to this event are too many to address here, I will touch on just a few of the most significant. There was a significant deposit of snow with a water equivalent of one to two inches of rain that was melted very quickly by an incoming warm front. The very same warm front that began to fill our system with snowmelt brought with it considerable rain estimated in the range of two and one-half to three inches. A third issue was that the soil's ability to absorb precipitation is considerably less in the wintertime due to alternating frozen and saturated conditions. Lastly, all this took place very rapidly and created, essentially, a "traffic jam" of water.

While it is important to understand that even best designed and maintained storm systems can be overwhelmed when subjected to events like this, we are still working to improve our system in order to minimize flooding no matter what nature throws at us. I have been researching complaints which my office received as well as listening to feedback from residents at council meetings. I have spent several days in the field personally walking our drainage infrastructure and searching for ways to improve the system. More often than not, it is discovered that there is no design/maintanance problems and the flooding occurred simply because Mother Nature dumped more on us than the system was designed to handle. That being said, I have found some situations that cause some concern.

I personally walked Robinson ditch and studied drawings of the area going back to 1967. After fully assessing the issue it was decided that a thorough cleaning of Robinson ditch from Debbie to Lear Nagle was a step towards improving the drainage in that area. Another point of concern was where Robinson crosses Pitts Blvd. The capacity of the pipes in this area is being studied and improvements are being investigated further.

We did inspections along Faulkner ditch beyond the city limits and into Avon. We contacted Avon officials regarding maintenance issues we discovered and made sure they were corrected.

We continue to police the developed areas within the riparian setbacks and work with property owners to remove any items which could be carried downstream and cause blockages in the event of heavy rains.

We are reviewing ditch crossings on private property city wide. I have no issues with property owners installing ditch crossings in order to utilize the property, but the crossings cannot diminish the capacity of the ditch. I have discovered some private ditch crossings that I suspect are undersized and will need to be addressed.

In addition to looking at the storm water system, we are planning on making improvements to a sanitary manhole at Ridgeview and Drake to reduce the chance of backups.

We are making every effort to provide you with the best performing infrastructure possible. Even in these times of shrinking budgets, we are planning on spending nearly \$200,000 dollars beyond the regular day to day maintenance on the above mentioned improvements. Thank you for your patience and understanding with regard to this very difficult situation.
