Did you Know?



The Service Department is in charge of all storm water, sewer and drinking water delivery systems inside the City Limits. They are also responsible for all paving, ditching, street cleaning, mowing, traffic lights, signs and much more. Should you have a problem with any system, please call 353-0814, or for after hours, the Police Department at 327-2191.



You can receive a sanitary sewer credit for filling your swimming pool as long as the pool is at least four feet in height and the water used is at least eighty percent of the volume needed to fill the pool. Call 353-0841 for more information. The following is a portion of Chapter 1294, Supplementary Regulations, of our North Ridgeville Codified Ordinances which govern swimming pools:

- 1) The Pool is intended and is to be used solely for the enjoyment of the occupants of the principal use of the property on which it is located.
- 2) It is not located, including any walks or paved areas or accessory structures adjacent thereto, closer than five feet to any property line of the property on which located.
- 3) A fence of at least four feet in height, but not more than five feet, and of a strength compatible with its intended use, shall be erected around the pool and be maintained at all times while the pool is filled. The fence shall have a gate which has its own lock or is capable of being secured by a lock, and it shall be kept securely locked at all times when the pool is not in use or attended by the owner or anyone using the pool with the owner's permission.

In the case of a pool elevated to a height of four feet or more, access to which is gained by a ladder or stairway, such access shall be removed or it shall be secured in such a way that no one may make entry to the pool when the pool is not in use.

As our City continues to grow and prosper with new residents and demand for more Police and Fire, road maintenance and other services, we must continue to search for new revenue streams to help fund these services.

The last few years have been successful to a point. Last year, 34 new businesses moved to North Ridgeville. Invacare expanded into a vacant building with 200 engineering jobs before that and JBC Technologies brought 50 new jobs and continues to grow. Pizza Pan Pizza Headquarters and Zannoni Distributors will take up residence in North Ridgeville in the coming months. There are many such as Wolf Bros. Distributing, Ten-Point-O Gymnastics, Drake Transportation, Sherwin-Williams and others who help our income tax revenue.

Yet there remain large parcels such as North Ridge Plaza, the Staubach property and others that could be developed to bring needed jobs, remove some of the remaining eyesores and bring in new tax dollars. To help accomplish this goal, the administration considered hiring a full time economic development person. However, a much more cost effective alternative was to retain a real estate development firm that had the contacts, staff, and wherewithal to do the extensive traveling necessary to get North Ridgeville in front of the right people. Collier's/Osterndorf Morris Public Sector Solutions was hired to develop marketing materials, make contacts and let the business world know what North Ridgeville has to offer, which is a lot!

To date, OM PSS has developed a marketing brochure that has been distributed to all of the Fortune 500 companies, 170 Real Estate Attorneys in NE Ohio, 375 local owners and developers and 60 attendees to our recent Business Summit. It is our hope that the contacts and meetings that are now going on behind the scenes will lead to more new and desirable businesses considering North Ridgeville as the place to be. We all know that North Ridgeville is a great place to live and work, but we need to let others know how great our City is and what we have to offer. OM PSS is working hard to accomplish just that.

Finally, we have been able to clean up the corner of Rt. 83 and Center Ridge Road. We removed several truck loads of gravel and replaced it with topsoil in which we can grow grass. Now, if we could just get some rain, we would have a nice looking grassy area until such time that we can move forward with a clock tower or similar structure.

The Softball World project continues to move forward. Preliminary engineering should be completed the week of July 16th. Once we have a good estimate on the cost of the road, we can negotiate an agreement with the adjacent property owner to share the costs of the road. Dirt is already being brought into the site and an agreement has been signed with Softball World allowing them to go ahead and begin preparation of the fields.

Water, Water Everywhere, But N'er A Drop To Drink

Sixty percent of our body is made up of water. Seventy percent of our brain is made up of water. We must replace two quarts of water each day through the foods we eat and the liquids we drink. More than 40 percent of North American lakes, ponds, and reservoirs are impaired due to pollution. Bacteria contamination closed more beaches and prompted more health warnings for the third straight year at ocean, bay and Great Lakes beaches, confirming that our nation's beaches continue to suffer from serious water pollution. Interesting statistics!

Lake Erie, through the treatment process its water undergoes, is as good as, if not better than, any bottled water. The next time you are at the library, check any of the leading consumer magazines. Most have reported on bottled water vs. tap water. According to a poll conducted by several dozen river and watershed groups, 85 percent of the voters around the country would prefer cleaning up polluted waters to drinking bottled water.

That being said, maybe someone could explain why people will not think twice about paying \$2 for a bottle of water but will complain if their water bill goes up \$2 per month.

Recently, there was a report that someone was dumping gasoline down the storm sewer. At almost \$3 a gallon, why would someone do that? However, upon investigation, no gasoline was found. Dumping volatile liquids such as gasoline, paint cleaner, kerosene, etc. in a closed system like a sewer can create a potentially explosive situation. If you need to dispose of any volatile liquids, hold them until the next County Hazardous Waste Disposal day which is scheduled for September 29, 2007 at Grafton City Hall, 17109 Avon Belden Road, Grafton, Ohio.

As City Engineer, I would like to request that we all respect this planet that we live on by picking up after ourselves, picking up our debris and not placing it in our ditches and watercourses, picking up our pet droppings and disposing of them properly, by cleaning our septic tanks as required by the County Board of Health and then, by taking a pleasant walk in the park.
