LEGAL NOTICE

Sealed proposals will be received at the Office of the Mayor, City Hall, 7307 Avon Belden Road, North Ridgeville, Ohio 44039 until 11:00 A.M. (Local Time) on May 22, 2019 and will be opened and read immediately thereafter for the:

WESTFIELD PLANT DECOMMISSIONING, WATER & SEWER EXTENSION

The work will consist of the decommissioning of the Westfield Drive Wastewater Treatment Plant; an extension of approximately 3,500 linear feet of twelve (12) inch sanitary sewer from Waterbury Boulevard (aka Shady Drive) along Sugar Ridge Road proceeding east for about 2,000 feet and then heading south to the existing Westfield Drive Wastewater Treatment Plant; and an extension of approximately 1,900 linear feet of eight (8) inch waterline from Sugar Ridge Road to Westfield Drive. Ancillary improvements include the full depth partial replacement and resurfacing of Sugar Ridge Road within the project limits, restoration of roadside amenities, and drive aprons disturbed during construction. Provisions in the construction documents also provide sanitary laterals with cleanouts to property owners along the sanitary extension for future abandonment of septic systems.

Bidders will be required to use the printed bid forms, which will be available along with the bid specifications from the Office of the Engineer, City Hall 7307 Avon Belden Road, North Ridgeville, Ohio 44039. Checks shall be made payable to the City of North Ridgeville, Ohio, at a non-refundable cost of seventy-five dollars (\$75.00) at the time of pick up. No documents will be mailed.

A mandatory pre-bid conference will be held at the Mayor's Conference Room, City Hall, 7307 Avon Belden Road, North Ridgeville, Ohio 44039 at 10:00 A.M. (Local Time) on May 14, 2019.

Each proposal shall be accompanied by a bid guarantee which shall consist of an Ohio Statutory Bid Guaranty and Contract Bond, substantially in the form prescribed by ORC 153.57 in a penal amount equal to or greater than 100% of the bid price. No other form of bond is acceptable. Bid security furnished in bond form shall be issued by a surety Company or Corporation licensed in the State of Ohio to provide said surety.

The City of North Ridgeville, Ohio reserves the right to reject any or all Bids and to waive any irregularities in bidding.

Each proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity.

Sealed bids must be marked on the front of the envelope: "Westfield Plant Decommissioning, Water & Sewer Extension"

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the Equal Employment Opportunity requirements of Ohio Administrative Code, Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9, shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Lorain County and the City of North Ridgeville, Ohio, as determined by the Department of Commerce, Division of Labor and Worker Safety, Bureau of Wage and Hour.
