# NORTH RIDGEVILLE CITY COUNCIL MINUTES OF REGULAR MEETING AUGUST 17, 2015

**CALL TO ORDER:** 7:30 P.M.

President Corcoran: Calling to order the Monday, August 17, 2015 regular Council meeting.

### **ROLL CALL:**

# **MINUTES - Corrections (if any) and approval:**

President Corcoran: You have before you the Council meeting minutes of August 3, 2015. Are there any corrections or objections to approving those minutes? Seeing none, those minutes are approved.

President Corcoran: Please note the Planning Commission meeting minutes of August 11, 2015.

Moved by President Corcoran and seconded by Arndt to bifurcate the lobby session to have two separate lobby sessions – the first is designed to allow people to speak on issues that are before Council that we are going to vote on this evening and the second session at the end of the meeting is to allow people to bring up any issues that they would like us to address.

# LOBBY (REGARDING AGENDA ITEMS ONLY):

President Corcoran: That means we are open for lobby session where you can discuss the items that are the on the agenda this evening. Please approach the podium and state your name and address for the record. You will be given three minutes to speak. Is there anybody who would like to address us on these items tonight? Seeing none we will move on to Administrator's reports. Mr. Mayor, you are up first.

#### **ADMINISTRATORS REPORTS:**

**A. Mayor:** Thank you Mr. President. The City received funding from the Ohio Public Works Commission to proceed with the phase one Jaycox Road reconstruction project. The contractor's specialized construction began the preliminary work today and the asphalt paving will begin August 25<sup>th</sup>. Two-way traffic will be maintained at all times with flaggers on duty to assist with traffic and to ensure safe work zones. Project details include reconstruction of Jaycox Road from approximately three hundred and fifty feet north of Center Ridge Road to approximately four hundred feet north of Drake Street. The total cost of the project is \$585,573.00 with OPWC funding at a level of \$345,000 with a grant.

Really briefly – Lear Nagle Road reconstruction has finally become a reality. Plans were submitted to ODOT for final approval. The Lorain County Engineer's office, who will manage the project, is looking to go to bid in October with work to begin in the spring. The total project cost is estimated at \$12,749,000.00. The City's responsibility, including water lines, is \$3,400,00.00. We will receive \$9,294,523.00 in federal and state funding or almost eighty percent of the total project.

NOPEC and the City have been getting numerous reports of door-to-door solicitors from at least one energy marketer, and I have heard of two, going door-to-door to residents stating that their community is no longer a member of NOPEC. This is completely false. NOPEC is the Northeast Ohio Public Energy Council which provides discounts on gas and electric. The City has been a member of NOPEC since its inception in 2000. If you have a solicitor that gives you false information, you can always verify our membership to NOPEC by calling my office or NOPEC directly. If you feel you have been moved or slammed to another supplier, you should call your utility company and report it. However, as I have seen done twice, before a supplier can move you to another program, you will receive a rescission letter from your utility and you have seven to ten days to rescind that enrollment if you really don't want to switch. With NOPEC, every two years, they send you a card. You can do nothing – in other words you are opting in. If you do nothing you become a NOPEC member. You still have the opportunity and the right if you want to go with a different supplier to opt out and go with the supplier. It is not binding you to NOPEC, but it makes it very simple if you want to belong to NOPEC.

The American Red Cross will be going through the neighborhoods between Lear Nagle and Pleasant Avenue this Thursday starting at 5:00 P.M. to install smoke alarms in homes that need them and to teach people about what to do in case a fire breaks out in their home. This is a free service as part of their Home Fire Preparedness Campaign. They chose those areas because it is very dense and they are older homes and they maybe more susceptible to fires. This is where they want to start with their program. Pleasant, Broad, Main and Lear Nagle areas.

North Ridgeville Heart and Sole Challenge – August 26<sup>th</sup> at Frontier Park. The speaker will be Mike Freeman, our Police Chief. If you can, join in and visit with Mike.

A reminder that this Thursday between 8:00 - 9:00 is coffee with the Mayor at City Hall. This Thursday.

Several years ago we started getting complaints about the intersection of Mills Road and 83. We still get three to four calls per week regarding traffic at that intersection. We had our traffic engineering firm, TMS Engineering, look at the intersection and make recommendations for improving traffic flow at that intersection. This is that report from 2011.

They recommended several changes in the timing of the lights, which we did. It only improved the service slightly and traffic has increased since then. I need to first explain that the intersection is half through North Ridgeville and half Avon with the City boundary running right down the middle of Mills Road. We then partnered with Avon after discussion with NOACA which revealed Mills was not listed on the National Highway Traffic System and could not receive federal funds. In working with Avon, that road is not qualified to receive federal funds for improvements. In September of last year, 2014, we received a copy of a traffic study that was completed by ODOT at no cost to us or to Avon. They suggested either widening the intersection with turning lanes or putting in a roundabout. There is a roundabout on that easel there. That is a conceptual drawing of what a roundabout at Mills and 83 would look like. Putting in traffic lanes to improve that intersection was estimated to cost \$927,000 and a roundabout was estimated to cost about a million based on this report. Subsequent to that, we met with an engineering firm, Structure Point, which specializes in roundabouts that estimated one could be built for approximately \$800,000 by moving the intersection slightly to the northeast by property owned by the City of Avon reducing our land acquisition costs which could not do turning lanes. This morning we met with the City of Avon and we agreed we should pursue joint venture to improve the intersection to install the roundabout with the potential installation date of summer 2017. Working together, we can use Ohio Public Works funds, which I am a board member of the integrating committee, and install this improvement at no or little direct cost to the residents of Avon or North Ridgeville. OPWC funds are grants which can be supplemented with interest free loans should direct OPWC funding not be enough. We do OPWC projects every year. The Jaycox Road that I mentioned earlier is this year's OPWC project. Next year's OPWC project will be the second phase of Jaycox and that is why we can't do this job until 2017.

In the coming weeks you will see legislation to retain Structure Point Engineering to begin engineering necessary to complete the project and today we requested a scope of services from them and we will need a cooperative agreement with the City of Avon to work together on this solution to a long time problem. Quoting from the ODOT study, a roundabout would decrease; it would provide a decrease in delay for the intersection as it would allow traffic to operate at more of a free flow condition with the implementation of a roundabout. Roundabouts provide an increase in traffic capacity and provide the highest reduction in crashes as are proven to reduce injury, fatal and overall crashes as compared with traditional signalized intersections. In addition with a roundabout, you don't have maintenance issues with controllers, road detections; you don't have to worry about power outages and sending a policeman down to direct traffic or put up signs. We look forward to your support as we work cooperatively with our neighbor to the north to make this a reality. Thank you and that concludes my report.

President Corcoran: Thank you Mayor. Mr. Safety-Service Director.

**B.** Safety-Service Director: To continue with road construction, over the last several months and actually a long time, we have been working with All Aspects, which is the company that is going to be tearing down the buildings and has already torn down Hales and the air conditioning, Amaro Heating and Cooling, which is off Ridgeview. The second week or the 5<sup>th</sup> of September, they will be starting and tearing down the home and the tattoo parlor which is directly across the street from the Corner Store. If they have clearance, then from the State of Ohio with regards to the asbestos related materials that could be in the Corner Store and are in the auto parts. It could move directly across the street as a continuous operation from there. They still do not have clearance on the BP site. The canopy had to be tested for asbestos. Those have not come back. I am not sure if there is any asbestos in metal, but that is a requirement of the state. I agree with Terry, Councilman Keenan, it is overkill as far as I am concerned, but they have to do that – it is part of the process.

Along with that, over the last couple years, in fact, longer before that, we are part of the Lorain County Land Bank. Pat Metzger is in charge of that program. If you are aware, in Lorain and Elyria, they have torn down blighted homes and ones that have been vacant that have been vandalized. On the list for this year for the City of North Ridgeville, which we have been working very hard with the land bank, is 6080 Olive Street. That house has had twenty-three violations since 2011. It is vacant and I will actually pass these pictures along so you can see the pictures of what we have gone through. Also on the list is 6315 Olive which has thirteen violations from 2011 and that is the home that actually was filled with water that we had to actually break into and the whole basement was full of water and also the whole house was full of mold. In 6641 Avon Belden, there are only five violations. Those started in 2012 but unfortunately, the bank took it over in 2014; it is completely covered in mold throughout the whole house and is also on the list to be torn down. I say on the list because; I guess someone can purchase a home at the last minute and something like this happens and pay everything off, but the plan is to have these homes taken out the first or second week of September. It has taken a long time to get there for these homes and we have several more to get on the list, but these are the three that we have. The County has graciously put them there to fund it as we start to clear out some of our homes rather than have Elyria and Lorain spend all of the money that we are part of the land bank. That completes my report tonight.

President Corcoran: Thank you Mr. Armbruster. Mr. Engineer.

**C. Engineer:** Thank you Mr. President. I planned on touching on the details of our Jaycox Road and Mayor so graciously and completely covered that. So I have no report.

President Corcoran: Thanks for coming Mr. Wangler. Mr. Auditor.

Councilman Arndt: I wonder, perhaps I direct this to Mr. Armbruster with regard to this investment of \$25,000, is this a process or a fee that is in addition to whatever we might be paying for one of our officers? Is this a one-time fee for this assessment? Mr. Mayor then, I apologize.

Mayor Gillock: We do these every two years. You have to maintain a promotional list and it is only good for two years and as we have an opening we go to that list. I believe they take the top three they can choose from. Some people that are on the list might find a job somewhere else or drop off for whatever reason; the list condenses and then every two years you have to do it again. This is the company that we hire to independently do that testing to establish that promotional list.

Councilman Arndt: Okay, so it is not testing necessarily for one candidate, but for a series of candidates. That answers my question. Thank you.

Councilman Keenan: Mr. President, a question I would have is do we do these concurrently with the police? Is there any efficiency/management of them both simultaneously?

Mayor Gillock: They are entirely different tests and in fact I think we use two different companies. I don't see how you can do them at the same time because the tests are not the same. Police do a much more, I think, involved physical aspect and they are; I call it the psychological exam – they sit the candidate down and they have a board of three officers and they grill him unmercifully. It is entirely different then with the Fire Department. It is more basically just a physical exam. There is written, but it is not nearly as intensive as police. They are entirely different.

Councilman Arndt: Those watching or listening, if you would give a couple sentences to explain what the TIF's are and the value that this brings to the community.

President Corcoran: I would love to. So this is not an additional tax. It is just a collection method for us to take the increase in taxes from a property that would normally go to the county. That money then comes back and stays within the City. It is the monies that are collected from that increase in property values for dedicated infrastructure improvements. It is a way to funnel money back that we would normally not collect. It funnels it back for us to address infrastructure needs throughout the City. It is an economic development tool that can be used to attract businesses but more importantly, it allows us to address infrastructure needs which in turn will spur economic development by itself.

Mayor Gillock: The only thing that I would add is the property owner pays essentially the same amount of taxes before and after TIF. As Kevin said, it is that money that is redirected but he pays the same taxes he did before. They are now just called piolets in lieu of taxes.

President Corcoran: Dr. Arndt and I were not here last time and I believe Mr. Costin you might have explained why the number was changing or where the money was coming from. If you could just go over that once again please?

Auditor Costin: We have another Ordinance, T 115, that was amended last meeting to allow the City to issue bond anticipation notes in the amount up to \$600,000 for the improving of the City's sanitary sewer system. You may recall, we had a BAN's issue as of two months ago that included the first million dollars that we thought would be adequate for the funding based on

engineers estimates. The City actually did a bid and it came out higher, substantially higher, than the estimated \$1,000,000.00. The City's position now is to wait until the end of September or early October and rebid that contract at which time we will know what amount, if anything, up to \$600,000 of additional costs we would need. If it is close to that number, we will issue additional BAN's. If it is something in the area of \$100,000 or so, we may just fund it internally. If we had to issue BAN's, that Ordinance would have to be passed before this construction Ordinance is allowed to be passed by our Charter. The proper sequence of events is that the Administration can submit a contract without the Ordinance passed, but they just cannot enter into the contract, but they can do the bid. Once we do the bid and we see where the numbers shake out, then we can issue the BAN's if needed. We will have passed that Ordinance and simultaneously, once we have approval for the purchase of the BAN's and a commitment, then we can issue the construction Ordinance that you are currently discussing. To make a long story short, or short story long, however you would have it that is the explanation.

Councilman Arndt: Mr. President, just for my edification, what is the purpose for the increased cost? If I recall, a couple meetings ago, the Mayor had mentioned that there is a distinction on how these bids come in dependent upon the time of the year, meaning it is busier.

Mayor Gillock: We worked with Engineering Associates out of Mansfield who gave us the original estimate of \$900,000 so we appropriated and went through the process for \$1,000,000.00. We went out for the bids in July and we received one bid which is about fifty percent high. We talked to ODOT and they are going through the same type of thing that bid year; all their bids were coming in thirty to fifty percent high. Part of the reasoning is this year they let almost two billion dollars in work and contractors are busy. When they bid in July, they have already had their work for the year and they are just taking a shot in the dark and maybe if I bid high if I get it. We only had one bid, we thought perhaps if we waited until early fall when the construction season is waning that they may be interested in getting work lined up for next year and we could hopefully get a lower bid. That bid that came in was about \$1,550,000.00 which is why we are saying up to \$1,600,000.00. If we get a bid at \$1,100,000.00 as Chris said, we won't issue the BAN's. This should give us the ability to do that and this sewer is a key part of the Center Ridge Road widening that we have to do before the road widening itself. We are okay time wise.

Councilman Arndt: I'm good. I don't doubt the need for that. I just wanted to understand why the disparity.

President Corcoran: Okay. Thank you. T 126.

For interim deposits based on prevailing market rates which is when we sell our CEDARS we are receiving applications from Buckeye Community Bank, Fifth Third Bank and Securities, First Federal of Lakewood, First Merit Bank, Huntington Bank, MultiBank Securities and Zions Bank. We are trying to use the local banks where we can, but we still want to get the best return on our dollar if we can. Thank you.

What we are finding is young professionals, teachers, young lawyers; we don't have much police presence in those areas. They have turned out to be really nice developments with private drives, private utilities so the City does not have to take care of them. They have been very successful. Pride One is wrapping up the development that they are on now and likes North Ridgeville and would like to continue developing here. We think they are pretty good projects, but I will say that based on our Charter, when land is rezoned to Multi Family Use, it is a ballot issue. It has to be approved by the Ward that the project is located in which is Ward 1 and also by the City. This is the beginning of the process to put this on the ballot to give the residents a vote on this. Thank you.

Auditor Costin: I don't think that this company would go out of business if we didn't pay within thirty days but that is more of a moral issue for Council to consider because the work has in fact been completed.

Mayor Gillock: I think the O.R.C. requires it to be paid within thirty days.

Auditor Costin: The O.R.C. requires Council to take action within thirty days.

Councilman Keenan: Mr. President, may I ask - a little clarification from the Auditor? Did you say this was completely funded through a federal grant?

Auditor Costin: Yes.

Councilman Keenan: So really it is money in and money out. We are not spending City dollars on this?

Auditor Costin: Well they are City dollars because it is grant money to the City. It is subject to the same City regulations. But it is in fact a source of those expenditures and is fully funded through federal grant. I would recommend that we pass this with the emergency because they do a very good job for us.

Mayor Gillock: Mr. President, this relates to our Community Development Block Grant funds. We get around \$400,000 every two years. CT manages that for us and there is an administrative

fee component to that. Chris is right, the money comes to the City so it is City money, but Terry is also correct that it is grant money going right back out.
