# NORTH RIDGEVILLE CITY COUNCIL MEETING MINUTES SEPTEMBER 20, 2021

## **CALL TO ORDER:**

President DeVries called the Monday, September 20, 2021 Council meeting to order at 7:00 p.m.

### **INVOCATION:**

Led by President DeVries.

## PLEDGE OF ALLEGIANCE:

Led by President DeVries.

#### **ROLL CALL:**

Present were Council members President Martin DeVries, Holly A. Swenk, Dennis Boose, President Pro-Tem Bruce Abens, Clifford Winkel and James R. Maleski.

Councilman Jason Jacobs was excused.

Also present were Mayor Kevin Corcoran, Safety-Service Director Jeffry Armbruster, Law Director Brian Moriarty, Auditor April Wilkerson, City Engineer Dan Rodriguez, Clerk of Council Nancy Linden, Deputy Clerk of Council Tina Wieber and Director of Public Utilities Tara Peet.

# **MINUTES - Corrections (if any) and approval:**

President DeVries asked if there were any corrections to the City Council meeting minutes of September 7, 2021. No discussion was offered. The meeting minutes stand approved as submitted.

President DeVries noted that Council received the August 2021 Building Department Report, the August 2021 Mayor's Court Reports and the August 2021 Water Distribution Reports.

## LOBBY:

President DeVries opened the lobby session. He asked anyone that would like to speak to come to the podium and state their name and address for the record. He further added each person will be given three minutes to speak. He requested anyone that wished to speak to fill out a lobby sheet located in the back of the room.

<u>Gary Crumley, 37773 Avalon Dr.</u> invited council members to sit with him in his drive to watch traffic. He stated the Republicans at the Corn Festival stated this was a done deal. He noted that there was a traffic flow issue in Avalon at non-peak times and further asked what was going to be done to address Avalon's issues.

<u>Deborah Evanish, 37748 Avalon Dr.</u> stated she was against the roundabout and added that Council should take her opinion and consideration. She felt Council was wasting her time and further felt the decision was already made and it was a done deal.

President DeVries stated Council has not voted and Council never said it was a done deal.

### **ADMINISTRATORS REPORTS:**

# A. Mayor:

Mayor Corcoran stated there were several pieces of legislation on tonight's agenda under first readings that he will be requesting emergency passage. The first ordinance is T 113-2021 authorizing the Mayor to enter into a contract with a consulting engineering firm for plans and specifications for the Chestnut Ridge Road and State Route 83 roundabout. The reason for the emergency is to meet the ODOT deadline.

Moved by Mayor Corcoran and seconded by Swenk to enter into executive session to discuss public employment.

The Council meeting reconvened at 7:24 p.m.

Mayor Corcoran stated there are four pieces of legislation - T 115-2021, T 116-2021, T 117-2021 and T 118-2021 he is asking for passage and the emergency this evening. T 115 is an ordinance creating a part-time cook position for our Senior Center and T 116 establishes the pay rate scale for this position. T 117-2021 is an ordinance creating a part-time van driver for the Senior Center and T 118-2021 establishes the pay rate scale for this position. The emergency is in order for the Office for Older Adults to move forward with hiring these two positions and to restore services to our senior population.

Mayor Corcoran stated the Service Department finished up paving on Emerald Street today and will now move over to the last three streets on this year's list – Broad Blvd., McKinley and Rose. These streets are anticipated to be prepped and milled beginning this Wednesday with paving to follow – all weather dependent.

Mayor Corcoran stated the Senior Center spaghetti dinner is Friday, September 24 from 5:00 to 7:00 p.m. Thank you to the North Ridgeville Lions Club for sponsoring this event. Enjoy the famous meal of spaghetti and meatballs, garlic bread and salad. Adults \$7.00, seniors \$6.00 and children 10 and under \$4.00; dessert \$1.00, pop \$.50 extra and carry out is also available. Presale tickets can be purchased at the Senior Center.

Mayor Corcoran stated the Fire Department will be hosting the annual Fire Safety & Health Fair on Saturday, October 2 from 10:00 a.m. to 2:00 p.m. at Fire Station #1, 7000 Ranger Way. This is a free event for the entire family to enjoy food, face painting, and other fun activities for the kids. There will also be information tables with fire safety and health tips for adults and children. There will be fire trucks and ambulances, police cars, Service Dept. trucks; and an emergency helicopter landing (weather permitting).

# **B.** Safety-Service Director:

Safety-Service Director Armbruster stated two of the portable LED signs moved to Gatestone; as requested. This has created an impact in this area. He also noted that the Hampton Place HOA

has been working with City and law department to purchase permanent signs for their street. Safety-Service Director Armbruster stated one has been installed in last two months and they came back and paid for everything. The City is not maintaining the sign.

# C. Engineer:

Engineer Rodriguez stated paint striping was to start this evening but pulled back due to the weather. They will begin Saturday, weather dependent, and the work will mostly be completed at night.

#### D. Auditor:

Auditor Wilkerson stated T 119-2021 is an appropriation amendment and T 122-2021 is the authorization of fund advances. Auditor Wilkerson requested the emergency clause for the necessary resources for expenditure.
