received by the agency the following week prior to the Civil Service meeting June 19.

Deputy Clerk Tjotjos stated that Civil Service may need to hold a special meeting to certify the candidates due to the timeframe of the written scores being received, the protest period, and the date the assessment scores are scheduled in.
