Correspondence received from Assistant Law Director Toni Morgan regarding a change to Rule V, Section 1.

Chairman Crevda asked Assistant Law Director Morgan to comment on the correspondence.

Assistant Law Director Morgan advised the reason she is suggesting this language to Rule V, Section 1 is a result of meeting with the Fire Chief. She advised on the application form there is a requirement that all of the candidates must be certified as paramedics at the time of filing their application. She advised that particular requirement isn't something that is related to the ORC and it is not one of the Commission's own Rules; it is just a requirement that facilitates the application process and at the time it was written this way, there were plenty of applicants. She stated what came out of the discussion with the Fire Chief was the desire to change some of the language on the application. She suggested in order to support this change or other similar changes that don't impact the ORC and are not changes to rules that already exist, to add to our rules the following statement: "Any additional requirements contained in the application or

application process which supplement or support the requirements of the Ohio Revised Code or the Civil Service Commission are considered to be a necessary part of the official application process and must be adhered to by the applicant." She advised it is a broad statement that what our application asks of the applicant is what we would expect them to do without having to change the rule or detail every time minor adjustments are made.

Chairman Crevda advised it seems like a more streamlined simple process. He asked if we need to take action on the rule change.

Assistant Law Director Morgan advised traditionally it is at the next meeting. She stated it was introduced today and at the next meeting the Commission would take action.

Co-Chairman Schiffbauer asked Assistant Law Director Morgan to confirm that right now in order to get on the list you have to be certified as a paramedic.

Assistant Law Director Morgan confirmed yes, in order to apply.

Co-Chairman Schiffbauer stated this rule change would allow the City to have access to a broader pool of applicants of very qualified candidates who are getting their paramedic certification but by the time they are hired, they have to have their paramedic certification.

Assistant Law Director Morgan confirmed that is correct. She stated this will include those who are in school and almost done.

Chairman Crevda advised they will revisit this rule change at the next meeting.

Deputy Clerk of Council Ciofani advised Assistant Law Director Morgan, Assistant Clerk of Council Ma, and she had a meeting with the Fire Chief regarding the upcoming Fire Entrance Exam, as the list is set to expire March 2022. She stated the Chief would like to start the process as soon as possible to expedite certifying a new list and she is giving the Commission notice that they will be seeing some items for the exam on the upcoming agendas.

Chairman Crevda asked for any other questions or comments. No discussion was offered.

It was moved by Crevda and seconded by Schiffbauer to adjourn the meeting.
