## NORTH RIDGEVILLE CITY COUNCIL MEETING MINUTES NOVEMBER 18, 2019

**CALL TO ORDER:** 7:30 p.m.

President Corcoran called the Monday, November 18, 2019 Council meeting to order.

#### **ROLL CALL:**

## **MINUTES - Corrections (if any) and approval:**

President Corcoran asked for any corrections to the City Council meeting minutes of November 4, 2019. No discussion was offered. The minutes stand approved as submitted.

President Corcoran noted that Council received the Building and Lands Committee meeting minutes of November 4, 2019 and the Planning Commission meeting minutes of November 12, 2019.

#### LOBBY:

President Corcoran opened the lobby session and stated there would be one lobby session this evening.

He asked anyone that would like to speak to come to the podium and state their name and address for the record. He further added each person will be given three minutes to speak. He requested anyone that wished to speak to fill out a lobby sheet located in the back of the room.

#### **ADMINISTRATORS REPORTS:**

**A.** Mayor: Mayor Gillock stated T 122, T 123 and T 124 are resolutions the give the City the ability to submit to the electors three renewal levies to be placed on the March 17, 2020 ballot. The three existing levies are Fire renewing at 1.9-mils, Police at 1.95 mils and Streets at 1.9 mils. Mayor Gillock asked that all three be passed with the emergency clause this evening in order to meet the filing deadline of December 18 with the Lorain County Board of Elections.

Mayor Gillock stated the Ohio Department of Transportation District 3 and the City will be having an information meeting regarding the US 20 (Center Ridge Road) major rehabilitation project tomorrow, Tuesday, November 19 from 6:00 p.m. to 7:00 p.m. at the North Ridgeville Academic Center Cafetorium. He also noted that there is a list of questions and answers to the most commonly asked questions posted on the City's website at www.nridgeville.org.

Mayor Gillock announced that City Hall offices will be closed Thursday, November 28 and Friday, November 29 in observance of the Thanksgiving holiday.

Mayor Gillock stated non-perishable food items and new toys are needed for the holidays for those less fortunate. He stated that there are collection boxes located at City Hall, Parks & Recreation and the Senior Center. The items collected will be donated to North Ridgeville Community Care. Mayor Gillock stated the deadline to drop off items is December 6.

- **B.** Safety-Service Director: Safety-Service Director Armbruster stated he wanted to reinforce the ODOT meeting tomorrow night to get answers to questions rather than reading Facebook or other social media with inaccurate information.
- **C. Engineer:** Engineer Rodriguez stated his department is closing out projects and reviewing some Planning applications.
- **D.** Auditor: Auditor Wilcheck stated T 127 is an ordinance to purchase a new ambulance. It was appropriated for 2019. The fund will need to be reauthorized once this purchase is made.
- **E.** Other Reports: President Corcoran noted Council received the October 2019 Fire Department Report, the October 2019 Police Support Car Report and the October 2019 Water Distribution Reports.
