COUNCIL LIAISONS REPORT:

SCHOOL BOARD LIAISONS REPORT:

JoAnna Timura reported that the school year started off great and this weekend is homecoming. We are out in the community trying to educate everyone on Issues 16 & 17 and trying to provide accurate information.

FINANCIAL REPORT:

Parks and Recreation Director Kevin Fougerousse discussed the revenues and expenses. Trust Fund revenue in August was \$20,535.21. Trust Fund unencumbered balance through August was \$215,951.89. The Park and Recreation Improvement Fund revenue in August was \$9,779.65. The Park and Recreation Improvement Fund unencumbered balance through August is \$265,028.34. Trust Fund expenses in August were \$32,592.13 and our General Fund expenses were \$27,698.13.

DIRECTORS REPORT:

Parks & Recreation Director Kevin Fougerousse discussed the 2 separate incidents in South Central Park. We posted a PSA on our Facebook® with the hope of catching the individuals who performed the property damage. The new playground installed by Snider Recreation at the Soccer Complex is complete and open to the general public. Snider Recreation will be back out to install signage and benches. The StoryWalk® installation was completed by volunteers with First Energy Corp. We held a ribbon cutting on September 23.

PROGRAM SUPERVISOR REPORT:

Our FallFest event will be held on Saturday, October 5 from 4:00-6:00p.m. in South Central Park. We will have a variety of activities for kids and families who attend. Spookville which is run by North Ridgeville Lions Club is on Friday, October 4 and Saturday, October 5 from 6:00-9:00PM in South Central Park. Cost to attend is \$2 per person. Tots Trick-or-Treat is for kids up to 5 years old and will be held on Friday, October 25 at 1:00p.m., our current enrollment is 101. Our first ever Fortnite Tournament is being held on Saturday, October 19 in Council Chambers. Our basketball skills clinic for kids in grades K-2 and 3-6 will be held in the NRAC for a total of 4 weeks, we currently have 25 pre-registered. Our Jr. Ranger Basketball Program is open to kids in grades 3-12. Our 1st & 2nd grade instructional basketball program runs for 6 weeks starting on January 4.
