**COUNCIL LIAISONS REPORT:**

Councilman Dennis Boose City is in full swing with road construction. Center Ridge Road is slated to be finished toward the end of June. The Roundabout construction at Alternate 83 and Chestnut Ridge is in the middle of being completed. There is construction also on Lorain Road and 480 interchange. The reconstruction of Mills Creek Road bridge is also currently underway. The City already started paving on Charles and concrete replacement starts later in the year. The Memorial Day Parade is put on by the Lions Club and VFW. The parade will start at 9:45a.m.

**SCHOOL BOARD LIAISONS REPORT:**

Kristen Iezzi stated the 2020-21 school year is winding down and the district is collecting Chrome books from the students. The seniors are graduating tomorrow at Rocket Mortgage Fieldhouse. They also had a senior fest yesterday that had food trucks and carnival like setting. They had prom this past weekend. We are in the final stages of HS Principal search. Our girls' softball team is currently playing and winning 8-2 at regionals. If they win they play Saturday.

**FINANCIAL REPORT:**

Parks and Recreation Director Kevin Fougousse discussed the revenues and expenses. Trust Fund revenue in April 2021 was \$28,465.28. Trust Fund unencumbered balance through April 2021 was \$227,078.48. The Park and Recreation Improvement Fund revenue in April 2021 was \$6,506.58. The Park and Recreation Improvement Fund unencumbered balance through April 2021 is \$223,732.16. Trust Fund expenses in April 2021 were \$14,020.67 and our General Fund expenses were \$66,940.58.

**DIRECTORS REPORT:**

Parks and Recreation Director Kevin Fougousse mentioned that Nicholas Blovsky resigned from the North Ridgeville Parks and Recreation Department due to family / personal issues. We wish Nick and his family the best.

**PROGRAM SUPERVISOR REPORT:**

We hosted our NRPRD Fishing Derby on May 1<sup>st</sup>,2021 and we had 124 pre-registered for the Derby. Our Adult Men's Basketball League starts on June 7<sup>th</sup> and we have 07 pre-registered. Our Tots T-Ball Program starts on May 28 and runs for 5 weeks. We have a total of 63 kids pre-registered. Our annual Touch-A-Truck event will be held on Saturday, June 5 from 10:00a.m-1:00p.m. at Shady Drive Complex. Movies in the Park are back and start on June 4. We will be hosting 4 movies this summer. Our Summer Concert Series is also back and that starts on June 13 and we will have 4 live events. Our Youth Tennis Program Session I starts on June 7 and runs through June 23. We have a total of 31 kids pre-registered between ages 4-14.

**GROUNDS MAINTENANCE REPORT:**

Marc Allen stated the staff fixed the t-ball fields this spring. The splash pad is ready and will open Memorial Day Weekend. We are waiting on parts from Vortex to install the bobbles. Councilman Boose asked about the contract with cemeteries and Marc Allen stated it is going well.
